**DUTIES:** Examines, analyzes, and processes all correspondence from insurance companies, employees, social security and social agencies, medical care facilities requesting clinical and administrative information about a patient's past and present records and data. Reviews each request and initially decides the best possible method of preparing the clinical information in response to the request(s). Insures and applies Privacy Act, Federal and State legal requirements and limitations. Determines the type and extent of information to be included in the reply, such as; insurance companies who are interested in different type of information verses social agencies, medical care facilities or welfare agencies. Whenever a medical opinion or diagnoses is requested employee contacts the attending physician. Reviews and chooses the appropriate format in reference to procedural claim and collection within applicable legal status, patient's consent and needs of the requestor prior to any release of any patient's information. Continual use of medical terminology is used each day in the process of third party claims and collections. Requests for medical records from other facilities and distributes medical documents upon arrival to appropriate physician. Determines appropriate sources from which to secure need medical information to fulfill the physician's requirements. Receives numerous records not requested by member of staff, such records are returned to sender requesting name of physician who requested the information. Prepares all typed materials in final format, in accordance with prescribed format, insure the accuracy of all spelling, punctuation, capitalization, proper sentence structure, and grammar. Assist customers with preparation of medical statement for patients who are incapacitated for work. In case where there is lack of documentation in the medical records, incumbent correlates fragmented-information, determining appropriated services to contact for additional validation of diagnoses. Researches, screens and correlates both old and current medical records to provide a systematic chronological history treatment received by patients from this and other treatment facilities. Annotates and logs all requests received from medical facilities, insurance companies, SSA, and VA. Dates, sorts and directs correspondence to proper personnel. Responds to correspondence within the time frame in accordance with departmental policy and procedures. Files patient's reports such as laboratory, x-ray, pathology, operative reports, narrative summaries, and consultation reports) in a timely manner and in accordance with JCAHO, IHS Regulations and Standards that govern medical Records Department and Policies. Insures that routine telephone calls, visitors', questions, for information relating to services, directions, instructions and coordination of activities are answered correctly and in a timely manner. Insures new employees, practitioner and other hospital staff are orientated and trained about the specialized medical records functions. Insures and maintains confidentiality of medical records. Review, purges and prepares files for shipment to Federal Records Center. Updates control logs. Registers patients, retrieves medical records and dispatches to proper hospital areas. Insures that pertinent portion of medical records in response to request for subpoena duces tecum. Performs other duties assigned.

**BASIC QUALIFICATIONS:** Candidates must have 52 weeks of specialized experience at the GS-04 grade level to qualify for the GS-05 grade level.

**SPECIALIZED EXPERIENCE:** Progressively responsible clerical, office, or other work that indicates ability to acquire the particular knowledge and skills needed to perform the duties of the position to be filled.

**PROFICIENCY REQUIREMENTS:** In addition to meeting experience or education requirements, applicants must present evidence of passing the typing proficiency from a school or other organization authorized to issue such certificate (*40 wpm typing speed; WPM are based on five minute sample with three or fewer errors. Certification must be within the last three years*). **SUBSTITUTION OF EDUCATION FOR EXPERIENCE:** Successfully completed education of four (4) years of education above the high school level in any field for which high school graduation or the equivalent is the normal prerequisite is creditable. This education must have been obtained in an accredited business, secretarial or technical school, junior college, college or university. *In order to obtain educational credit, you are required to submit a copy of official transcript(s) by the closing date of this announcement.*

**SELECTIVE PLACEMENT FACTOR:** NONE

**TIME-IN-GRADE REQUIREMENTS:** A candidate may be advanced to a position in grade GS-5 or below if:

- (1) The position is no more than two grades above the lowest grade level he/she held within the proceeding year under non-temporary appointment; or
- (2) He/she met the above restriction for advancement of the grade of the position to be filled, at any time in the past; or
- (3) He/she previously held a position to be filled, at any time under any type of appointment.

**LEGAL AND REGULATORY REQUIREMENTS:** Candidates must meet time-after-competitive appointment, time-in-grade, and qualification requirements by the closing date of the vacancy announcement.

**WHO MAY APPLY**

Merit Promotion Plan (MPP) Candidates: Applications will be accepted from status eligibles (e.g., reinstatement eligibles and current permanent employees in the competitive Federal service) and from current permanent IHS employees in the Excepted Federal Service who are entitled to Indian Preference.

Excepted Service Examining Plan (ESEP) Candidates: Applications will be accepted from individuals entitled to Indian Preference. Current Permanent IHS Excepted Service employees and Competitive Service employees or Reinstatement eligibles entitled to Indian Preference may also apply under the provisions of the Indian Health Service Excepted Service Examining Plan. These candidates **MUST** indicate on their application whether their application is submitted under the IHS Excepted Service Examining Plan or both.

If you are a displaced Federal employee, you may be entitled to receive special priority selection under the ICTAP. To receive this priority consideration, you must:

1. Be a displaced Federal employee. You must submit a copy of the appropriate documentation such as RIF separation notice, a letter from OPM or your agency documenting your priority consideration status with your application package. The following categories of candidates are considered displaced employees.
  - A. Current or former career or career-conditional (tenure group I or II) competitive service employees who:
    1. Received a specific RIF separation notice; or
    2. Separated because of a compensable injury, whose compensation has been terminated, and whose former agency certifies that it is unable to place; or
    3. Retired with a disability and whose disability annuity has been or is being terminated; or
    4. Upon receipt of a RIF separation notice returned on the effective date of the RIF and submits a Standard Form 50 that indicates "Retirement in lieu of RIF"; OR
    5. Retired under the discontinued service retirement option; or
    6. Was separated because he/she declined a transfer of function or directed reassignment to another commuting area. OR
  - B. Former Military Reserve or National Guard Technicians who are receiving a special Office of Personnel Management (OPM) disability retirement annuity under section 8337 (h) or 8456 or Title 5 United States Code.
2. Be applying for position as or below the grade level of the position from which you have been separated. The position at or below must not have a greater promotion potential than the position from which you are separated.
3. Have a current (or last) performance rating of record of at least fully successful or equivalent. This must be submitted with your application package. (This requirement does not apply to candidates who are eligible due to compensable injury or disability retirement.)
4. Occupy or be displaced from a position in the same local commuting area of the position for which you are requesting priority consideration.
5. File your application by the vacancy announcement closing date and meet all the application criteria (e.g., submit all required documentation, etc)
6. Be rated well qualified (a score of 80 on a rating scale of 70 to 100) for the position including documented selective factors, quality ranking factors, physical requirements with reasonable accommodations and is able to satisfactorily perform the duties of the position upon entry.
