Recommended service delivery plan by product line based upon projected workload, key characteristics, patient classification and tribal and IHS input.


Resource Allocation

Executive Summary

Service Area Description

The Sonora Health Center, serving the Primary Care Service Area Communities listed to the left, is located in the city of Sonora, California approximately 96 miles SE of Sacramento and 72 miles E of Stockton and 53 NE of Modesto.

As part of the MACT Health Board, it is a hub of primary care for Native Americans living in Tuolumne County. It sends most of its referral workload to Sonora Regional Medical Center and Tuolumne General Hospital. Tertiary Care can be found in Modesto, California. Nursing Home care is provided in Sonora.

As noted in the Service Summary to the left, Sonora Health Center plans to operate as a 40 hour per week Health Center with complete primary care services along with Health Education, Case Management, Diabetes, Transportation and Maternal Child Health programs.

Facility Description

The Sonora Facility built in 2000 is approximately 293 SM in a leased retail shopping center.
