3. **Quick Health Data Online** provides county, state, regional and national data for all 50 states, the District of Columbia, and US territories and possessions. **Trainings are currently scheduled for October 20, 22, 26, 28, and November 10, 12, and 18, 2009**. Data are available by gender, race, and ethnicity, and in certain cases, by age. The data come from a variety of national and state sources. Information is organized into a number of categories, including demographics, mortality, maternal health, reproductive health, violence, prevention, disease incidence, mental health, and access to care. Funding Opportunities:

1. The National Service Agency announces **changes to availability of AmeriCorps Planning Grants**. Major changes to the planning grant competition include, **1) the competition is now also open to organizations that want to plan AmeriCorps programs in one state, 2) the total funds available increased by \$250,000 to \$750,000, and 3) the application deadline has been extended to January 26, 2010**. Physicians, Nurses, Nurse Practitioners, Physician Assistants and Pharmacists who are involved in the care of Native Americans or Alaskan Natives.

Program Goal

To increase the quality of HIV/AIDS care and treatment for Native Americans living with HIV. This program will provide a three-day HIV/AIDS clinical training practicum that covers the spectrum of HIV disease for targeted health care providers working with Native Americans.

Program Objectives

Upon completion of this three-day educational program the

participants should be able to:

- ❖ Have an understanding of the natural history of HIV infection, and use laboratory testing in establishing the diagnosis of HIV Infection.
- ❖ Assess when to initiate antiretroviral therapy.
- ❖ Summarize long-term complications of antiretroviral therapy and understand the management of drug toxicity.
- ❖ Understand the role of resistance assays and its use in clinical management.
- ❖ Increase knowledge and skill in caring for adults with HIV infection through direct observation in the out-patient clinic and participation in case discussions.
- ❖ Apply the concepts of cultural sensitivity in delivering care to Native American patients by understanding Native American Health care traditions.
- ❖ To be able to assess the clinical manifestations of Pediatric HIV Infection and utilize treatment standards in the care of the pediatric patient.

IMPORTANT INFORMATION TO ASSIST TRIBES WITH APPLYING FOR THE American Recovery and Reinvestment Act (ARRA) of 2009 Communities Putting Prevention to Work (CPPW)

U.S. Department of Health and Human Services
Centers for Disease Control and Prevention (CDC)

PURPOSE OF FUNDING

The ARRA of 2009 includes a total of \$650 million for evidence-based clinical and community based prevention and wellness strategies that support specific measurable health outcomes to reduce chronic disease rates. This Funding Opportunity Announcement (FOA) is designed to address the Health People 2010 focus areas of nutrition and overweight, physical activity, environmental health, and tobacco use.

This FOA is only for **non-research activities** supported by the Centers for Disease Control & Prevention (CDC) and is intended to fund highly qualified applications from applicants with the following experience and support in place: active coalitions and demonstrated experience working with community leaders to implement policy, systems and environmental change strategies; demonstrated support from the Tribal leader or other equivalent official; demonstrated support from all public school districts within the intervention area for the collection of Youth Risk Behavior Surveillance System data; and demonstrated ability to meet reporting requirements (required by the Recovery Act in section VI.3 Reporting Requirements – please see the www.nihb.org for more details).

TECHNICAL ASSISTANCE

With the recent announcement of the Communities Putting Prevention to Work (CPPW) funding opportunity through the ARRA, the National Indian Health Board (NIHB) is offering assistance to the Tribes with **“Media Messaging & Health Communications”** pieces that are required for the proposal submission. The NIHB is available to discuss this and other potential partnerships with Tribes and Area Indian Health Boards to continue in its efforts towards a healthier Indian Country.

WHO IS ELIGIBLE TO APPLY

TRIBAL COMMUNITIES: Federally recognized Tribal Governments, Regional Area Indian Health Boards, Urban Indian organizations, and Inter-Tribal Councils as designated by the Principal Tribal elected official or chief executive officer will serve as the lead/fiduciary agency for tribal applications.

Other Eligible Applicants:

Large cities: The official local health department (or its bona fide agent), or its equivalent, as designated by the mayor, county executive, or other equivalent governmental official, will serve as the lead/fiduciary agent for a Large City application. For this announcement, the term “large city” is defined as a local health department that serves a jurisdiction with a population of more than 1 million people.

Urban areas: The official local health department (or its bona fide agent), or its equivalent, as designated by the mayor, county executive, or other equivalent governmental official, will serve as the lead/fiduciary agent for an urban area application. For this announcement, the term “urban area” is defined as a local health department that serves a jurisdiction with a population more than 500,000 and up to 1 million people.

State-coordinated small cities and rural areas: The official state health department (or its bona fide agent), or its equivalent, as designated by the Governor, is to serve as the lead/fiduciary agency for Small City and Rural Community applications. For this announcement, the term “State” includes the 50 states, the Commonwealth of Puerto Rico, the Virgin Islands, the Commonwealth of the Northern Mariana Islands, American Samoa, Guam, the Federated States of Micronesia, the Republic of the Marshall Islands, and the Republic of Palau. The term “small city” is defined as a local health department that serves a jurisdiction with a population between 50,000 – 500,000 people. The term “rural area” is defined as a local health department that serves a jurisdiction with a population of 50,000 people and below.

AWARD AMOUNTS

- Approximately **30-40 awards** will be made for the CPPW Initiative Funding and work should begin on or about February 26, 2010 for a **24 month budget period**.
- Additional funds (up to \$10 million) will be made available for a limited set of awardees to provide peer-to-peer mentorship to other funded communities

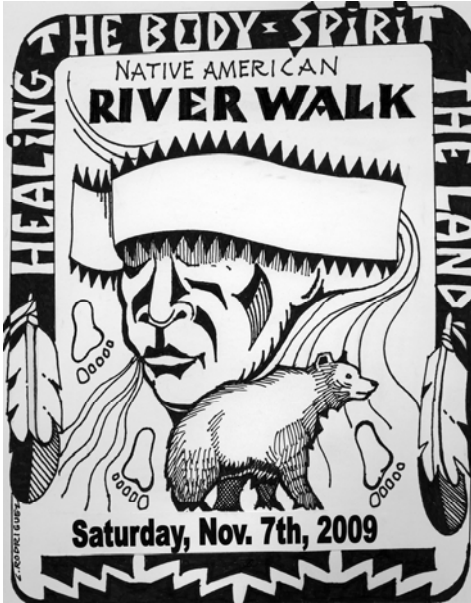
