GUIDELINES SUBMITTED

Isolation Rooms: CAPT Radtke postponed any discussions until next month. CDR Byrns was not in attendance and was unable to provide any information for discussions.

Refrigerant Management Plan: Motion by CDR McFarland to adopt the Refrigerant Management Plan, US General Services Administration, Public Buildings Service, Real Property Management and Safety, September 1992, as a guideline. Mr. Pucillo seconded. All four members voted in favor of adopting this guideline. This guideline will be issued accordingly for inclusion in the IHS Technical Handbook.

CADD: Motion by Mr. Pucillo to accept the CAD Layer Guidelines Recommended Designations for Architecture, Engineering, and Facility Management Computer-Aided Design, The American Institute of Architects, 1990. CDR McFarland seconded. All four members voted to adopt this guideline. This guideline will be issued accordingly for inclusion in the IHS Technical Handbook.

Other Issues: Mr. Pucillo noted an editorial error in page 55 of the Guidelines For Construction and Equipment of Hospital and Medical Facilities, 1992-93; Table 3, Area designation - Protective isolation room, Filter bed no.2. Change the data (90) as shown to the correct number (99.7).


The next conference meeting will be May 12, 1993, Wednesday, 12:00 PM EST. Please be prepared to discuss the following guidelines:
