Dear Great Plains Area Tribal Leader and Urban Indian Organization Leader:

I am writing to inform you of a tribally-requested date change for the first onsite Tribal Consultation and Urban Confer Session on the organization and structure of the IHS Great Plains Area. In my June 2 Tribal Leader Letter, I highlighted the June 3, 2016-dated *Federal Register* Notice, in which Indian Health Service (IHS) opened a 90-day comment period to request written comments by Tribes, Tribal Organizations, and Urban Indian Organizations located in the Great Plains Area on the structure of the IHS Great Plains Area. The Notice also announced a series of Agency-convened in-person and telephone Tribal Consultations and Urban Confer sessions. **This letter provides a new date and locations for the onsite Tribal Consultation and Urban Confer sessions. The *Federal Register* Notice has also been updated with this information.**

The IHS is requesting comments and recommendations on the organization and structure of the IHS Great Plains Area Office as part of ongoing efforts to become more patient-focused and better meet the needs of the American Indians within the Great Plains Area. Specific topics may include, but are not limited to, the geographic location of the IHS Great Plains Area Office, centralization or further decentralization of Area Office services, staffing, budget, local involvement, transparency and oversight, partnerships, accountability, monitoring, and how the Area Office can support the service units.

Telephone Tribal Consultation and Urban Confer Sessions

The Tribal Consultation and Urban Confer sessions are open to elected or appointed leaders of Tribal Governments and their designated representatives, and recognized representatives from Urban Indian Organizations. Representatives from other Tribal organizations and Native non-profit organizations are welcome to attend as observers.

Those wishing to participate in the discussions must have a copy of a letter signed by an elected or appointed official or their designee, which authorizes them to serve as a representative of the Tribe. This documentation should be submitted no later than (3) days in advance of the Tribal Consultation and Urban Confer Session. Written comments by Tribes and Tribal Organizations can be e-mailed to consultation@ihs.gov. Written comments by Urban Indian Organizations can be e-mailed to urbanconfer@ihs.gov.
