1. Human Resources Reform for the IHS - White Flint Amphitheater

This session will focus on the new assessment process and the important role of managers and supervisors in the hiring process. The IHS is using a new automated hiring system called USAStaffing and it requires a new way of doing business. Participants will be able understand the 80-day hiring model, and the steps that fall in and out of the 80-day timeframe as well as the specific responsibilities of managers and the tools available to them. 4. Health Information Technology Update - Glen Echo

This presentation will focus on current IHS initiatives in Health Information Technology. Topics will include the Certified EHR and the OIT's efforts to promote Meaningful Use in Indian Country, as well as a description of current and planned development in the Clinical and Practice Management suites of RPMS applications. The presentation will also provide an overview of other high priority Information Technology initiatives of interest to I/T/U leaders, particularly in the areas of information security and operational support. The Directors of the Divisions of Information Security and Information Technology Support will be present to answer questions on how these initiatives will impact operations in the field. At the end of this session, attendees will understand the impact of the MU initiative and its potential to improve health care services provided by IHS, Tribal and Urban facilities. They will learn how the RPMS clinical application suite is being enhanced to address user and program requirements, and how these enhancements will support high quality care for American Indian and Alaska Native people. They will also learn how OIT is upgrading the Practice Management suite and how this development will improve user satisfaction and strengthen our support for Tribal users of RPMS.
