Preface

The Patient Registration system (AG) is an application that exists in the Resource Patient Management System (RPMS). The system is used to register and manage patient records and is used for all other RPMS applications. Statistics and data are gathered from the Patient Registration system.

A Windows-based interface has been developed. Please reference the documentation for the Practice Management System (BPRM), Patient Registration for updates.

1.0 Introduction

Please review these changes and add a copy of them to any printed documentation your site may be using for Patient Registration (AG) v7.1. These changes will be integrated into future versions of the software, and user manuals and will no longer be considered an addendum at the time of the next release.

The addendum only provides guidance on changes made in the patch that are relevant to the user. To see a list of all changes made in a patch, please refer to the patch notes for each of the respective patches.

1.1 HHS Social Security Number (SSN) Reduction and Elimination

The HHS Information Systems Security and Privacy Policy (IS2P), published in July 2014, which establishes the Department's policy for the collection and use of SSNs. A memorandum includes the criteria for determining when collections and uses of the SSNs at HHS is authorized, process for reviewing and approving these collections and uses of SSNs, processes for establishing SSN inventories, and steps to take to reduce and eliminate unnecessary use of SSNs.

1.2 Summary of Changes

This patch contains changes to support the Social Security Number Fraud Prevention Act of 2017 and the Social Security Number Reduction Act.

P17 provides enhancements and software fixes to v7.1 of the Patient registration application. Specifically, this patch adds the following functionality:

- Patient Preferred Name (PPN) display for the EMB/IND/FIE options
- Social Security Number (SSN) edit/view requires Security key (AGZVIEWSSN)
- New Cell Phone Number field for Add/Edit options
- Cell phone number display on Face Sheet
- New Advance Directive and Notice of Privacy Practices error/warnings
- Inactive Communities are filtered out from selection list and are marked inactive in Community History
- Updated code of MPI

2.0 Patch 17 Changes

2.1 Patient Preferred Name (PPN)

The PPN will display if a preferred name has been entered in Patient Registration. The display shows as **Demo, Patient – Preferred Name***.

Note: Preferred name field and lookup was released in AG v7.1 p15. Refer to p15 addendum for more details.

The following menu options have been modified to display the PPN.

2.1.1 Print Face Sheet, Index card, Embossed card

The PPN displays on the printed Face sheet, Index card and Embossed card [**AG – PTRG – FIE or FAC**] as follows:

2.2 Social Security Number (SSN)

Patient Registration [AG – PTRG – ADD / EPT] Social Security field requires the AGZVIEWSSN security key to edit or delete the patient's SSN. Upon initial entry using the ADD option, the user is allowed to enter the SSN without the key assigned.

If the user without the keys attempts to edit the SSN field the following message will be displayed:

User is not authorized to edit SSN information.

Note: A SSN cannot be deleted if it is in a "Verified by SSN" status.

Below are examples of the display for a user who does **not** hold the AGZVIEWSSN security key:

Note: Warnings do not generate if patient is deceased or has been inactivated.

2.5 Inactive Community

Modifications were made to prevent the user from selecting an inactive community. The selection list will **not** display an inactive community based on the date moved.

Note: The community codes are managed in the Standard Code book. Contact your Area Statistician for any community code updates. Refer to the IHS Standard Code Book website for the latest list of active/inactive community codes.

Example: KAKE has two entries with one being inactivated on April 1, 2018 and another is still active. If the Date Moved is before April 1, 2018, the two selections will be listed, otherwise a Date Moved today would only display Kake, County: Prince of Wales-Hyder.
