

Influenza- Like Illness Surveillance Report IHS Influenza Awareness System (IIAS) (Week 51: 12/13/2020 – 12/19/2020)

- IHS national Influenza-like illness (ILI) activity is low at 0.7%, below the IHS baseline of 1.93%
  - Five out of ten IHS Areas reported an increase in ILI activity, while other IHS Areas reported having consistent or slightly increased ILI activity from the previous week.
  - This week's IHS ILI activity is below the CDC's ILINet ILI activity for week 51 (1.54%), below the ILINet baseline (2.6%) and the IHS baseline of 1.93%.
- To date, IHS has administered 200,468 doses of influenza vaccine.
- Overall, 27.9% of the IHS Active Clinical population ages 6 months and older has received an influenza vaccine this season to date.
- Tucson Area did not report or reported insufficient data and are excluded from analyses this week.
- Alaska Area is excluded because only one facility is exporting ILI data files and would not be representative of the entire Area.










