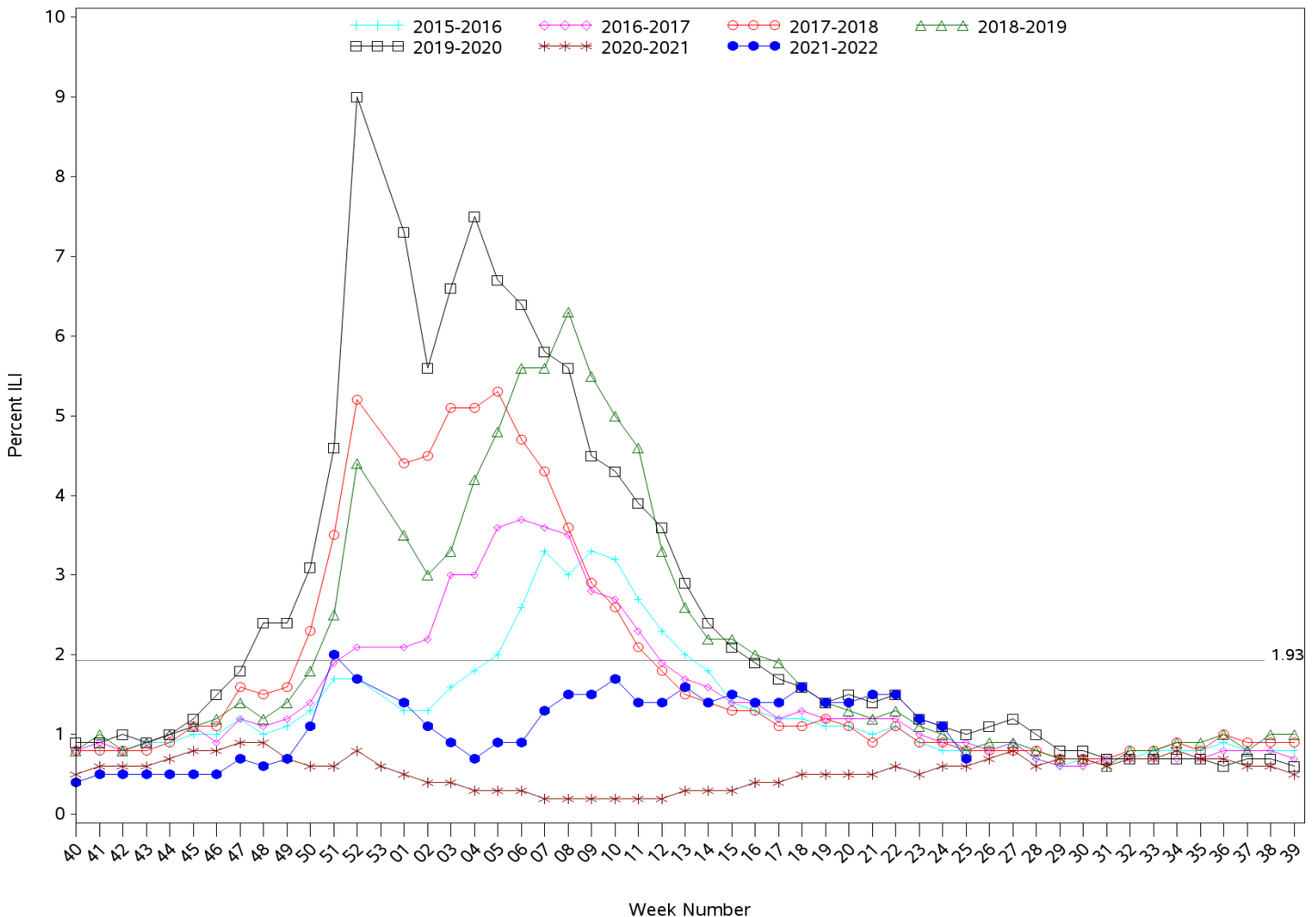

Influenza-like Illness Surveillance Report
IHS Influenza Awareness System (IIAS)
(Week 25: 06/19/2022 – 06/25/2022)

- IHS national Influenza-like illness (ILI) activity is low at 0.7%, below the IHS baseline of 1.93%
 - Eight of the eleven IHS Areas reported a decrease in ILI activity, while the remaining three Areas reported a slight increase or no change in ILI activity from the previous week.
 - This week's IHS ILI activity is below the CDC's ILINet ILI activity for week 25 (1.82%) below the ILINet baseline (2.5%) and the IHS baseline of 1.93%.
- To date, IHS has administered 308,693 doses of influenza vaccine.
- Overall, 35.2% of the IHS Active Clinical population ages 6 months and older has received an influenza vaccine this season to date.

Percent ILI visits is number of ILI visits divided by total number of daily outpatient visits.

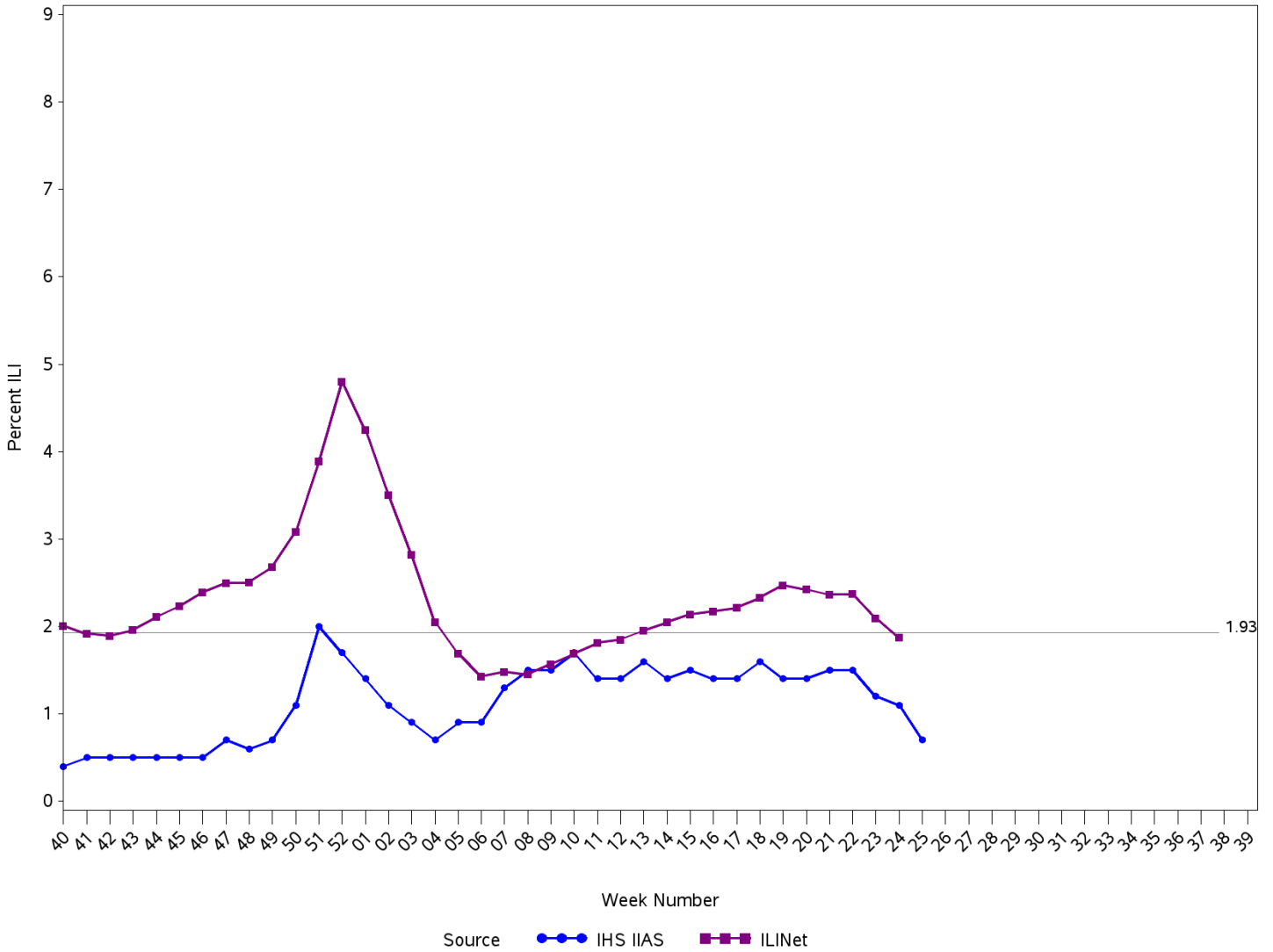

Baselines are computed as the mean percentage of ILI patient visits during non-influenza weeks (as defined by CDC) for the previous three seasons, plus two standard deviations.

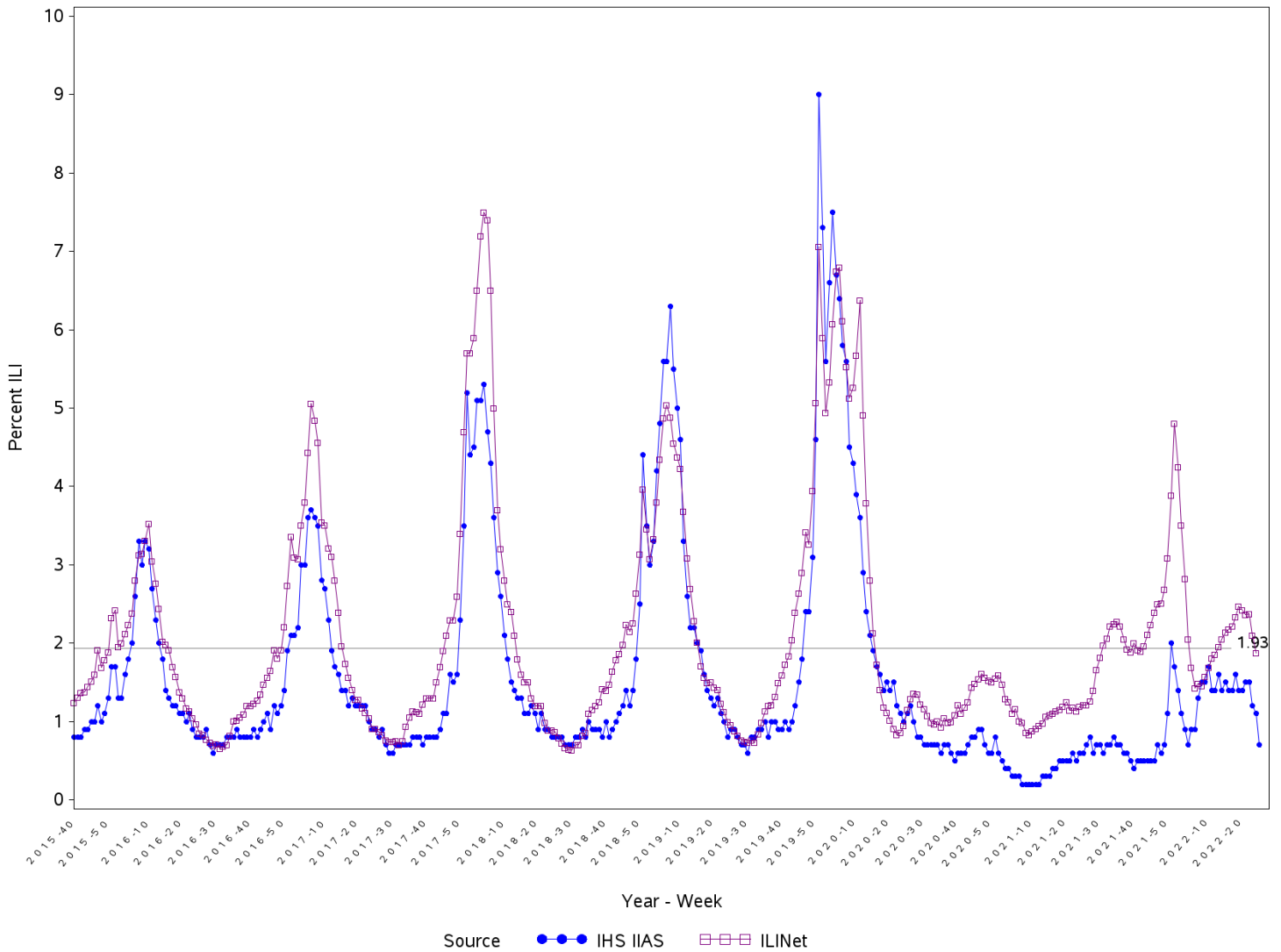

10/03/21 through 06/25/22 (Week 25)**



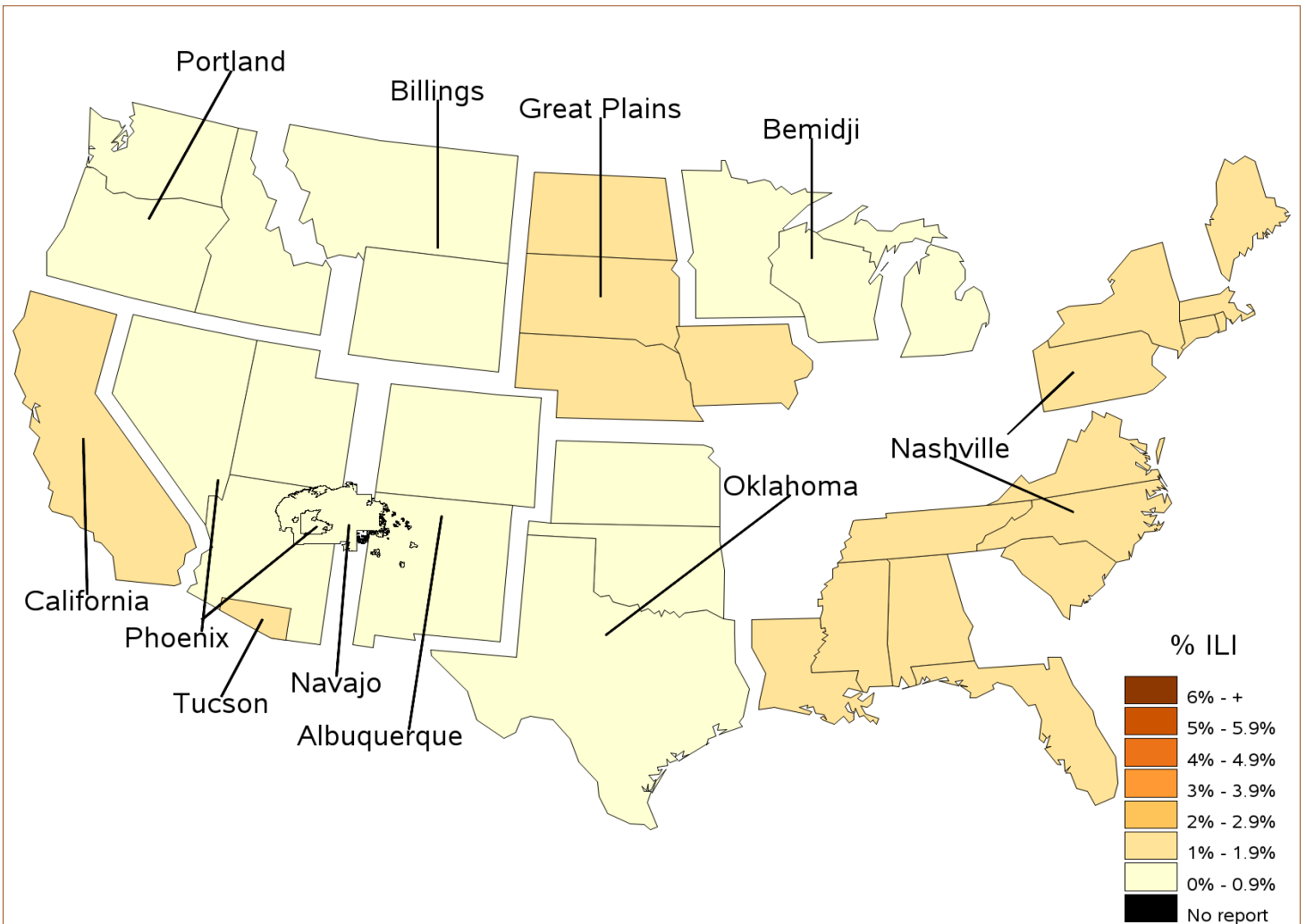

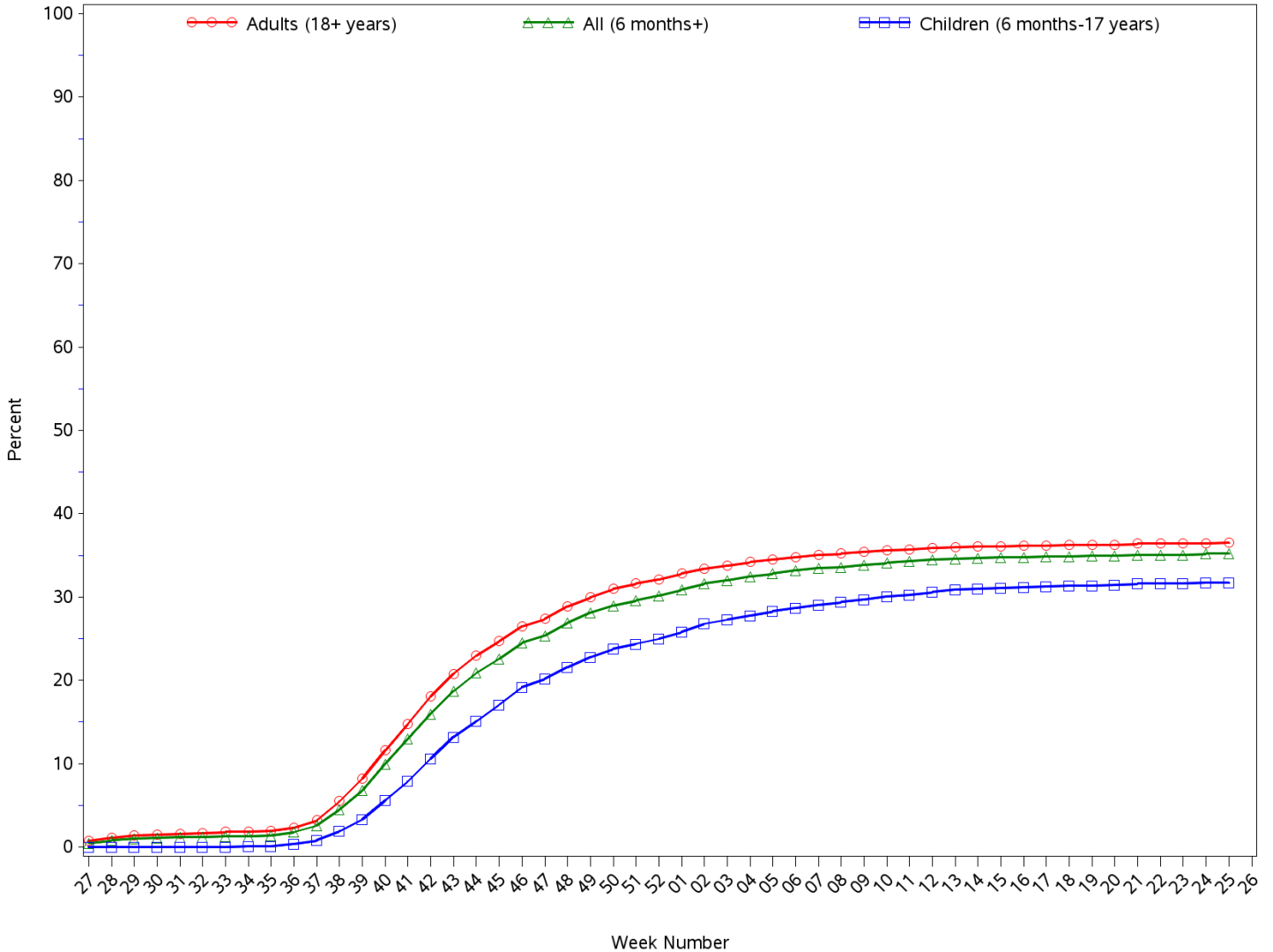

IHS Influenza Vaccination Surveillance

As of 06/25/2022, sites reporting to the IIAS have administered 308,693 doses (1st and 2nd) of seasonal influenza vaccine to active clinical patients 6 months of age and older.

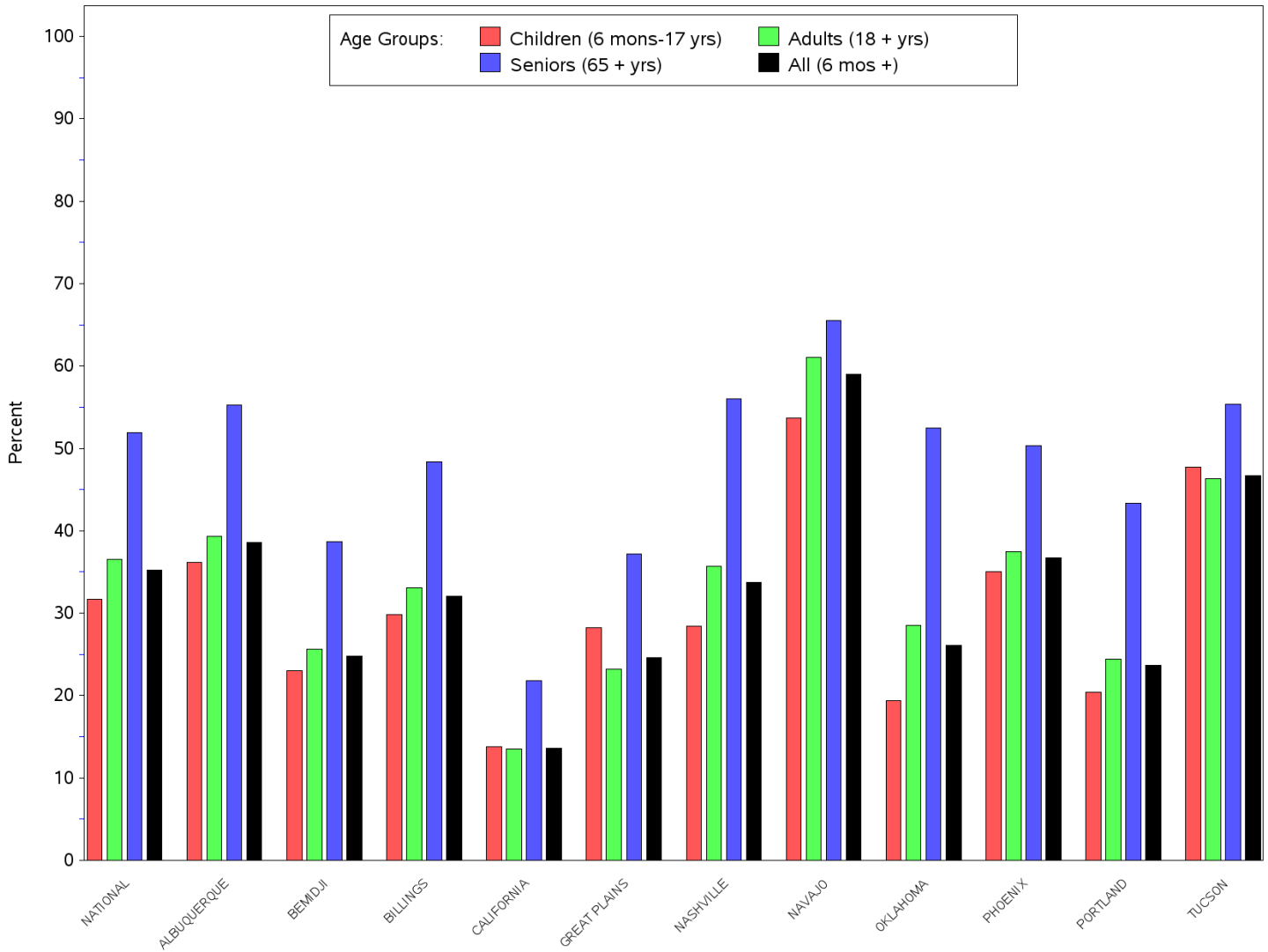
