Dear Tribal Leader and Urban Indian Organization Leader:

I am writing to initiate Urban Confer to seek your input and recommendations for a new 5-year Indian Health Service (IHS) Office of Urban Indian Health Programs (OUIHP) Strategic Plan. Your input will help to improve Agency practices to more effectively engage Urban Indian Organization (UIO) leadership and promote meaningful discussion to identify priorities.

In 2017, the IHS developed an <u>OUIHP Strategic Plan 2017-2021</u>, pursuant to the Consolidated Appropriations Act, 2016, Pub. L. No. 114-113, 129 Stat. 2242, 2568, which described what the Agency hoped to achieve over the next 5 years, based on the participation and feedback received from UIO Leaders, IHS staff, and other stakeholders. Recommendations received helped develop the mission, goals, objectives, and strategies that were included in the final plan.

In fiscal year (FY) 2022, the expectation is to evaluate the existing OUIHP Strategic Plan and to develop a new 5-year OUIHP Strategic Plan. The new 5-year OUIHP Strategic Plan will include goals, objectives, strategies, and performance measures, based on input from UIO Leaders, partners, and external stakeholders.
