Overview

The NDW Export Tracking Mart provides the sending sites with information about the status of their export files. This status is generated during the processing of their files into the National Data Warehouse (NDW).

The NDW Export Tracking Mart environment exists on the ROHAN Business Objects web reports server which is separate from the NDW Production environment. The Export Tracking application is an application within the IHS National Data Warehouse Reporting web site.

All users of the Mart have access to the following components:

- NDW Export Tracking Application
- NDW Export Tracking Data Mart User Guide
- Post Data Load Report Error Messages Guide

In addition, Registered Users of the Mart have access to the following reports:

- Files Reflected in Workload/Userpop Mart
- NDW Files Loaded into the Data Warehouse

Overview of the Export Tracking Mart Process

The Export Tracking Mart provides the sites access to the status of their exported files processed into the National Data Warehouse (NDW). The following diagram displays the flow of the export file statistics from the Area sites to the Mart.




Figure 1 - *Export Tracking Mart Process*

Overview of the Export Tracking Application

The following diagram displays the Export Tracking Mart and the components of the Export Tracking Application.

- CURRENT VIEW Code Files

- View ET_RPT.V_EXPORT_INFO stored in the Sandia Database
- Export Tracking Data Mart User Guide, accessed via the **HELP** button




Figure 2 - Export Tracking Mart and Export Tracking Application

Export Tracking Application Code File Functions

The export file statistics are collected to track all exports received by the NDW. The data is stored in table ADMIN.EXPORT_INFO in the NDW. The data in this table is utilized by view ET_RPT.V_EXPORT_INFO as a source for the Export Tracking Application which consists of the below Code Files. Based on selected search parameters, the application displays statistical data for one or more export files. Additionally, the Code Files are stored on the ROHAN server in the folder \DLTWEB.

Public Code Files

CURRENT.ASPX – Languages: ASP.Net, JAVA

- Displays the CURRENT VIEW web page.
- Handles page formatting.
- This is the main code file which calls all sub code files.

TOP.ASPX – Language: ASP.Net2

- Formats the NDW graphic header.
- Processes the HELP button.

INTRANET\COMPONENTS – Language: JAVA

- Handles the CALENDAR functions and Date selections.

Private Code Files

WEB.CONFIG – Language: XML

- Handles the Database connections and Database security.
- Handles the Database name with the Servers DB2 client ODBC connection.

GLOBAL.VB – language SQL, VB.Net2

- Processes the Database and User information.

CLASSES.VB – Languages: VB

- Handles the DB2 Traces and SQL command settings/configurations.

CURRENT.ASPX.VB – Languages: SQL, VB, JAVA

- Processes TIME OUT for web site,
Database selection and CHECK,
Input selection of the Export ID from view ET-RPT.V_Export_Info,
Input selection of the Page Number,
Input selection of the Date range from view ET-RPT.V_Export_Info,
Handles the red font letter (**R**) for the rejection file display.
- Handles the input selection and drill down functions for fields AREA and SITE
and stores retrieved Export Files statistics for display.

CURRENTGLOBALVAR.VB – Languages: SQL, VB.Net2

- Handles the display of the Export Files statistics to the CURRENT VIEW web page.

Export Tracking Mart Reports and Documents

The reports and documents are posted on the IHS National Data Warehouse Reporting web site (ROHAN) in the Export Tracking Mart folder using the Business Objects Web application interface.

Reports

The two Export Tracking Mart reports, developed using Crystal Reports software, are:

1. SPF1. Files Reflected in Workload/Userpop Mart
Lists for each Area, the file statistics for all export files loaded to the NDW and reflected in the Workload/Userpop Data Mart.
 - FILENAME: WL_UP Export Files.rpt
2. SPF2. NDW Files Loaded into the Data Warehouse
Lists for each Area, the file statistics for all export files processed into the NDW.
 - FILENAME: NDW_Status_Report.rpt

For detailed descriptions of the reports, see the *NDW Export Tracking Data Mart User Guide*.

The code for both of these reports is stored on the ROHAN server at <\\rohan\reports\NDW reports\03.Export Tracking Mart\CrystalSourceCode\STATUS OF PROCESSED FILES>.

Export Tracking Mart Database Objects

The SQL Code for the view ET_RPT.V_EXPORT_INFO is stored by DB2 in the appropriate system table (SYSIBM.SYSVIEWS) in the TEXT field.

Export Tracking Application View

The Export Tracking Application View contains all columns and rows from the NDW table ADMIN.EXPORT_INFO with an ERROR_CATEGORY_CD that is not equal to 'F'. The ORIG_LD_DT for the export file is displayed in the CURRENT VIEW as the LOAD_TARGET_DT.
