Service Delivery Plan


Recommended service delivery plan by product line based upon projected workload, key characteristics, patient classification and tribal and IHS input.

Executive Summary

Service Area Description

The Oneida Service Area, serving the Primary Care Service Area communities listed to the left, is located east of Syracuse New York. The Oneida Nation is currently involved in a land claim over approximately 270,000 acres.

As part of the Nashville Area, Oneida is the sole facility of the Oneida Nation Service Unit overseeing the delivery of healthcare for Oneida Nation members.

It sends most of its referral workload to Syracuse. The closest alternative care options can be found in Syracuse for Primary, Secondary, and Tertiary Care.

As noted in the Service Summary to the left, Oneida operates as a Health Center.

It provides a moderate spectrum of outpatient health services along with supporting ancillary services.
