

Construction Contract Update

- Will be awarded to a design/build contractor
 - Contractor will do both the design and construction
- Currently in Phase II of selecting the contractor(s)
- Estimated to be awarded and design start date: April 2017
- Estimated construction start date: January 2018
 - ***Groundbreaking Ceremony to be planned***
- Estimated construction completion date: March 2019

Pre-construction Activities

- Drainage Study:
 - -100% complete
 - Drainage Study Report reviewed and approved by IHS and county engineers
 - Computer modelling found that our project will not hydrologically affect surrounding areas
 - Basically: we will not increase the flood depth due to the displacement of our building.


Pre-construction Activities

- Traffic Impact Study:
 - –Study complete
 - Determination by traffic engineer consultant:
 - a left-hand turn lane is required at the driveway to the site, as well as a right-hand turn apron.
 - -Primary reason is because 65% of the time, a car turning left into Sacred Oaks would have to stop on the road and wait to turn.
 - Safety improvements recommended by consultant

Pre-construction Activities

- Traffic Impact Study:
 - Yolo County requested removal of eucalyptus trees along CR31
 - Trees are completely pruned on north side due to power lines, and not pruned on south side – leaning into road.
 - IHS would be responsible for maintenance of trees.
 - Therefore, if trees were to fall into road, it would be at the fault of IHS.
 - Removal of trees would increase driver safety
 - Currently blocking the line-of-sight (aka sight distance) for Sacred Oaks vehicles leaving the facility and turning onto CR31.


Traffic Impact Study: Proposed Design



Traffic Impact Study: Proposed Design




Traffic Impact Study: Sight Distance
