Spring 2018, the IHS will initiate a Tribal Consultation on our Working Draft Sanitation Deficiency System – Guide for Reporting Sanitation Deficiencies for Indian Homes and Communities (SDS Guide). The last formal update was May 2003.





List of Conferences and Dates for FY 2018

Annual Providers' Continuing Medical Education/Diabetes Day on May 21-24, 2018 in Sacramento

In 2017, 352 attendees earned over 1,200 continuing education units/credits.

Annual Dental Continuing Education on May 7-10, 2018 in Sacramento

In 2017, over 400 attendees each had the opportunity to earn over 30 continuing education units.





Government Performance & Results Act (GPRA) Update

California Area Tribal health programs met the targets for 11 of 27 GPRA measures in FY 2017, and improved on 11 of 22 measures with comparable results in FY 2016

FY 2017 was the final year of GPRA reporting through RPMS. Beginning with the current fiscal year, 2018, reporting will occur through the Integrated Data Collection System (IDCS) at the National Data Warehouse

- This will allow ALL sites to report for GPRA, including non-RPMS health programs
- More information on accessing data through IDCS will be offered via webinars throughout the remainder of the year

Government Performance & Results Act (GPRA)

Clinical GPRA measures where we excelled:

- Poor Glycemic Control (blood sugar)
- Ideal Glycemic Control (blood sugar)

Clinical GPRA measures where we need work:

- Controlled Blood Pressure <130/80
- LDL Assessed (bad cholesterol)
- Nephropathy Assessed (kidney function)
- Retinopathy (diabetic eye) Exam
- Immunization (influenza 65+, pneumovax 65+, childhood)
- Pap screening
- Mammography screening
- Tobacco cessation
- Alcohol screening
- Domestic/intimate partner violence screening
- Depression screening
- Prenatal HIV screening





Hep C – Status Report

29 of 37 clinics with suitable capability have initiated screening and treatment

Nine programs have screened more than 50% of their baby boomer population

OKLAHOMA – 122 Patients Cured at 5 Sites

CALIFORNIA – 191 Patients Cured at 5 Sites

Although definite conclusions cannot be reached from this simple assessment, it is clear CA Tribal clinics are making good progress making big differences in people's lives.





Emergency Pharmacy Program

Clinic access to a pharmaceutical acquisition system in CA if needed during an emergency

The VA has agreements with numerous pharmacies in CA

Transportation agreements allow the VA to ensure delivery to homes if necessary

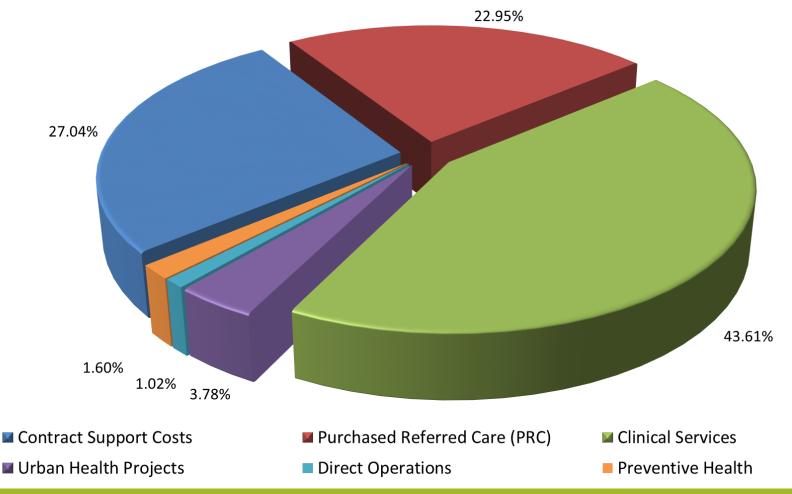

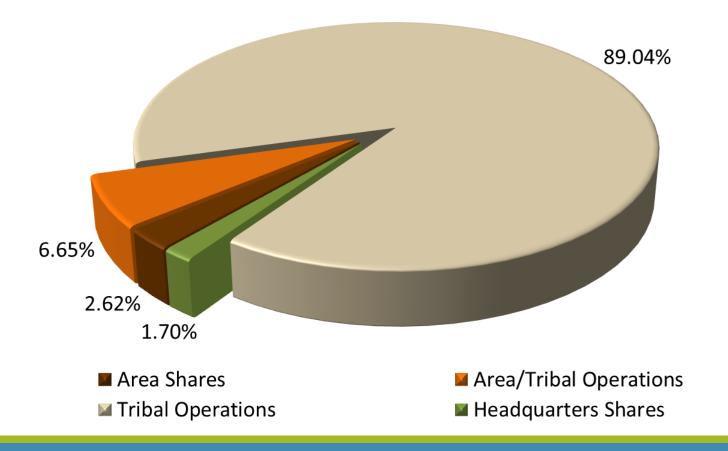
Allocation of Budget FY Ending September 30, 2017

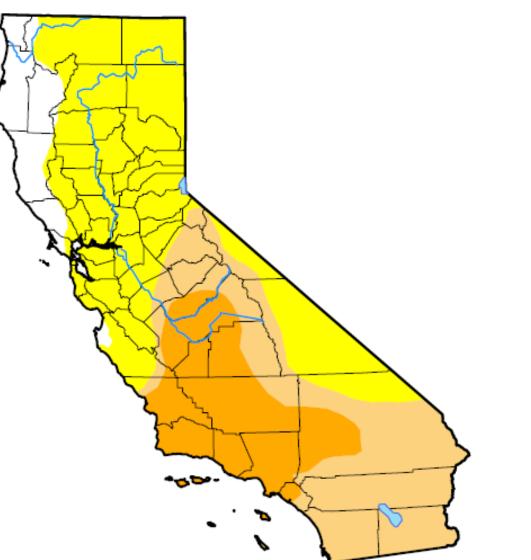

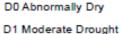

Drought Conditions (Percent Area)

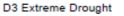

Facility Condition Assessments – Area Wide	Required condition assessments (aka "deep-look surveys") to be completed in 2018-2019. Condition assessments required every 5-7yrs. Last completed in 2012.





Division of Environmental Health Services

DEHS will award just over \$37,000 in injury prevention minigrants in 2018. Award letters will be distributed in March.
