
- California Area IHS provides technical assistance to 35 California T/U programs through remote telecommunication to improve outcomes

Providing Services During Covid

Walk with Ease

Walk With Ease (WWE) is a 6-week long evidenced-based program that helps people with arthritis or other related conditions reduce pain, increase balance, increase strength, improve walking pace, and improve overall health. The WWE program includes a free workbook and an app that you can download to track your progress.

Format: Due to COVID-19, this program is self-directed with guidance from a trained Walk With Ease leader from Lake County Tribal Health. A group of individuals begin and end the 6-week program at the same time.

When: Starts January 12, 2021

Time: Any time that works for you, three times a week on days of your choosing

Length: 6-weeks: Three 1-hour sessions each week (a total of 18 sessions)

Current SDPI Grant Cycle

- SDPI, normally a 5 yr cycle, was extended to 7 yrs (FY 2016-2022)
 - FY 2016
 - FY 2017
 - FY 2018
 - FY 2019
 - FY 2020
 - FY 2021
 - FY2022

SDPI Funding

- The Consolidate Appropriations Act, 2021 funded SDPI at \$150M through 2023
- No increase in SDPI funding since 2004
- A portion of unobligated balances used to cover sequestration & one-time SDPI 2021 Supplements

SDPI Updates: 2022

- 2022 was a Continuation Competitive application; only current grantees were eligible to apply
- Sequestration: 2% mandatory sequestration.
 \$3M decrease (total SDPI funding \$147M)
- Offsets: 2 SDPI grantees received offsets across
 12 Areas
- No offsets for CA SDPI grantees in 2022

SDPI FY 2023

- FY 2023 will be the 26th year of SDPI
- Unknown if the grant application process will be "limited" to only current grantees or "open" to all eligible applicants
- IHS is submitting a waiver request to HHS to limit the application process to current SDPI grantees only
- Notice of Funding Opportunity (NOFO), May 2022

SDPI 2023: Tribal Consultation/Urban Confer

- DTLL and DUIOLL will be sent out soon and will open the consultation/confer process
- 30 day period to submit comments
- Consultation/confer (April 2022)
