Current California State PRCDA

Entire State of California, excluding the counties of Alameda, Contra Costa, Los Angeles, Marin, Orange, Sacramento, San Francisco, San Mateo, Santa Clara, Kern, Merced, Monterey, Napa, San Benito, San Joaquin, San Luis Obispo, Santa Cruz, Solano

Tejon Indian Tribe : The State of California including Kern, CA.⁶⁵, Stanislaus, and Ventura, is designated a PRCDA ([25 U.S.C. 1680](#)).

- ▶ ⁶⁵ On December 30, 2011 the Office of Assistant Secretary-Indian Affairs reaffirmed the Federal recognition of the Tejon Indian Tribe. Kern County, CA, was designated administratively as part of the Tribe's CHSDA in addition to the CHSDA established by Congress for the State of California. Kern County was not covered when Congress originally established the State of California as a CHSDA excluding certain counties including Sacramento County ([25 U.S.C. 1680](#)).

Wilton Rancheria, California: The State of California including Sacramento, CA.⁷²

- ▶ ⁷² The Wilton Rancheria, California had Federal recognition restored in July 2009 as documented at [74 FR 33468](#), July 13, 2009. Sacramento County, CA, was designated administratively as part of the Rancheria's CHSDA in addition to the CHSDA established by Congress for the State of California. Sacramento County was not covered when Congress originally established the State of California as a CHSDA excluding certain counties including Sacramento County ([25 U.S.C. 1680](#)).

Current PRC Eligibility in California

42 Code of Federal Regulations (CFR) §136.23 - Persons to whom contract health services will be provided.

- PRC services will be made available as medically indicated, when necessary health services by IHS facility are not reasonably accessible or available, to persons described in and in accordance with 42 CFR §136.12 if those persons:
 - 1) Reside within the United States and on a reservation located within a PRCDA, or
 - 2) Do not reside on or near a reservation but reside within a PRCDA and:
 - a) Are members of the Tribe or Tribes for which the reservation was established; or
 - b) Maintain close economic and social ties with that Tribe or Tribe

PRCDA: Communities of Residence

- ▶ Even though the entire State is a PRCDA, minus those 20 counties, many SU in California Area only provide PRC funding to members of federally recognized Tribes living on their reservation OR members of their Tribe who live in a community of residence assigned to their SU, this varies by Tribe and is dependent on their PRC funding amounts and policies
