Description:

Cannabis (Marijuana) is one of the most widely used recreational substances with use among teens now exceeding even that of tobacco. Although many teens believe cannabis is harmless, mounting evidence indicates that adolescent cannabis use increases vulnerability to develop various psychopathologies. There nevertheless remain debates regarding the causal link between cannabis use and psychiatric outcomes and little information regarding the biological systems related to these risk that can serve as targets for potential treatments. During this webinar, the healthcare team will be provided research about the effects of phytocannabinoids.

Outcomes/Objectives:

1. Examine effects of specific phytocannabinoids, such as tetrahydrocannabinol and cannabidiol, on the adolescent brain and observed behavior.
2. Appraise potential effects that tetrahydrocannabinol and cannabidiols have on psychiatric risk and therapeutic interventions.
3. Identify epigenetic contributions to neuro-biological underpinnings of inter- and intra-generational effects of cannabis.

Target Audience:

Physicians, Nurse Practitioners, Nurses, Pharmacists, Social Workers, Psychologists and other members of the healthcare team.
