## Description:

Many Tribal and Urban Indian healthcare programs utilize 340b to obtain medications at discount prices. Health programs rely on these discounts to provide medications to the communities they serve and use the savings to improve clinical services. This webinar will offer practical direction on how to prepare and submit the Combined Purchasing and Distribution Model (CPDM) to HRSA if operating multiple sites and sharing inventory or serving patients across sites.

- 2. Examine the process and key points for developing the combined purchasing and distribution model for your healthcare program.
