Description:

This webinar will share the new immunization registry data exchange requirements. In addition, this webinar will present the benefits of sharing data to avoid missed opportunities for care and over/under immunization.

Outcomes/Objectives:

1. Examine the impact of new California legislation (AB-1797) on immunization providers and updates to the California Immunization Registry (CAIR).
2. Identify how CAIR benefits patients and providers.
3. Accurately exchange immunization data with CAIR to ensure a statewide comprehensive immunization record base.

Physicians, Nurse Practitioners, Nurses, Pharmacists, Social Workers, Psychologists and other members of the healthcare team.
