Description:

The American Diabetes Association released new Standards of Care in 2022. This webinar will summarize the new standards as they relate to management of cardiovascular disease and chronic kidney disease in people with type 2 diabetes.

Outcomes/Objectives:

1. Apply evidence-based treatment recommendations for hypertension treatment in patients with type 2 diabetes and chronic kidney disease.
2. Assess and determine when to utilize novel therapies for cardiovascular risk reduction in patients with type 2 diabetes and chronic kidney disease.
3. Demonstrate role in therapy metformin plays in patients with type 2 diabetes and chronic kidney disease.
