Description:

Households experiencing food and nutrition insecurity are at higher risk of chronic illness such as diabetes. This session will discuss screening for food insecurity as well as resources to offer to the community to decrease food insecurity.

Outcomes/Objectives:

1. Appropriately screen for and respond to food insecurity in the clinical setting.
2. Identify health outcomes related to food insecurity and refer for services as needed.
3. Collaborate with community resource programs to reduce food insecurity in AI/AN communities.

Target Audience:

Physicians, Nurse Practitioners, Nurses, Pharmacists, Social Workers, Psychologists and other members of the healthcare team.
