Description:

The rates of child and teen media use have gradually been increasing since the release of the iPhone approximately 20 years ago; however, during and following the COVID-19 pandemic, rates of media use have skyrocketed with a disproportionate impact on communities of color, including American Indian/Alaska Native (A/AN) youth and families. This session will discuss the standards of care and best practices established by major pediatric medical organizations related to screen time. This session will also discuss how to conduct media histories when working with patients.

Outcomes/Objectives:

1. Identify cognitive, psychological, social, emotional, and other impacts of excessive screen time in AI/AN youth and families.
2. Apply current guidelines from the American Academy of Pediatrics (AAP) and the American Academy of Child and Adolescent Psychiatry (AACAP) to conduct an effective media history when working with AI/AN youth.
3. Provide families with effective tools to set media priorities for their children.

Target Audience:

Physicians, Nurse Practitioners, Nurses, Pharmacists, Social Workers, Psychologists and other members of the healthcare team.
