#### Description:

This session will increase practitioner awareness of American Indian and Alaska Native (AIAN) smoking disparities and will provide current evidence-based prevention and cessation strategies. The session will include dental clinic innovations for supporting cessation, integration of dental and primary care sides of the clinic to create a continuum of care to bolster cessation support with internal and external partners.

#### Outcomes/Objectives:

1. Apply USPSTF Guidelines for screening and counseling patients to quit commercial tobacco use.
2. Integrate an evidence-based approach for quitting commercial tobacco use to meet GPRA benchmark measures.
3. Incorporate cultural competency recommendations that are effective in treating tobacco use.

Physicians, Nurse Practitioners, Nurses, Pharmacists, Social Workers, Psychologists, Dentists, and other members of the healthcare team.
