SUBJECT: Fiscal User Population Estimates — FY 2012 Revised

Fiscal year 2012 (FY) user population estimates have been revised and included in the attached tables. Following Tribal consultation and Area review, IHS is releasing the estimates, the result of our collaboration with Tribes to reconcile and validate data.

The IHS staff used the same statistical concept that has been used in prior years to produce the estimates (unduplicated count by residence of Indian registrants who have had direct encounters with—or contracted for—IHS inpatient, ambulatory, or dental services during the last three years). The attached tables contain final user population estimates as well as data used to develop the estimates. Also attached in a description of the columns.

Attachments

Description of the Table Columns in the FY 2012 IHS User Population Service Unit Tables

Column 1, Indian Registrants —

This is the total count of Indian registrants that were in the Indian Health Service (IHS) National Patient Information Reporting System (NPIRS) Patient Registration data base as of September 30, 2012. The registrants were tabulated by their service unit of residence.

A registrant is considered Indian if (1) the Tribe Code is designated as “Indian”; or (2) the Tribal designation is “unspecified”, and - the classification and/or the Indian blood quantum code is “Indian”.

Column 2, Active Indian Registrants —

This is the count of Indian Registrants in the NPIRS data base who had at least one direct or contract inpatient stay, ambulatory care visit or dental visit between October 1, 2009 and September 30, 2012.

Column 3, Indian User Population Estimate —

This is, in most cases, the same as the number of Active Indian Registrants shown in Column 2. This is generally not the same as a list of members of a Tribe since those members must be seen in the past three years at an IHS or Tribal health facility and have at least one workload reportable encounter documented and electronically sent into the National Data Warehouse in one of the two standard formats (HL7 or Simplified) from an electronic medical records system. The only two exceptions occur when there was a negotiated figure for a Tribe which has been receiving services from IHS for less than three years or where county splits or community additions to service units negotiated in advance with the Tribes concerned are calculated by the Area Office and added to the table.

Delta County is divided between the two service units by community in the UPI and UP3 Tables. The three affected tribes receive credit for active users in Delta County regardless of which service unit their community of residence falls in. Eastern Michigan Service Unit tribes Little Traverse and Sault Ste Marie received credit for 49 (5.7%) and 714 (83.2%) of the active users in Delta County, respectively. The Western Michigan Service Unit Tribe, Hannahville, received credit for 95 (11.1%) of the active users in Delta County. This percent split resulted in 7 active users being moved from the Eastern Michigan Service Unit to the Western Michigan Service Unit.
