Description:

Colorectal Cancer Screening rates are low nationwide. This presentation will review the Colorectal Cancer Screening measure logic and discuss best practices to improve colorectal cancer screening rates among American Indians/Alaska Natives.

- 1. Examine recent changes to the United States Preventive Services Task Force Colorectal Cancer (CRC) Screening guidelines, and the reason for these changes.

- 3. Employ strategies that have been utilized to increase Colorectal Cancer Screening in various Tribal health programs.
