This presentation will discuss COVID-19 and diabetes among American Indians/Alaska Natives (AI/AN), including trusted, reliable sources of information and data regarding the impact of COVID-19 and local-level treatment, care, education, and community support to address COVID-19 and diabetes simultaneously.

Outcomes/Objectives:

1. Examine current data and information on the impact of COVID-19 among AI/AN people.
2. Assess local community needs for diabetes care, education and available services for AI/AN peoples.
3. Provide appropriate diabetes care and support for AI/AN communities despite COVID-19 pandemic/endemic conditions.

Physicians, Nurse Practitioners, Nurses, Pharmacists, Social Workers, Psychologists and other members of the healthcare team.
