- Part 3 of the SDPI application is a review of your annual IHS diabetes audit National report
- Data for accountability vs. data for improvement
- The time period for your grant work plan is different than your National diabetes audit time period (except for Cycle 2)
- Make sure you know how to run computer reports on your selected Measures

Diabetes Audit Year	Date Range	Available on WebAudit?
2012	1/1/2011 – 12/31/2011	No
2011	1/1/2010 – 12/31/2010	Yes (still draft)
2010	3/1/2009 – 2/28/2010	Yes

SDPI Grant Cycle	FY Dates
1	October 1 – September 30
2*	January 1 – December 31
3	April 1 – March 31
4	June 1 – May 31

Setting targets



- Compare to your clinic's previous data
- Compare to the all-California audit data
- Compare to Healthy People 2020 targets
 - HbA1c <7.0 target is 58.9%
 - ✦ Two A1c tests in a year: target is 71.1%
 - Controlled Blood Pressure target is 57%
 - Annual Dental Exam target is 61.2%
 - Annual Food Exam target is 74.8%
 - Annual dilated Eye Exam target is 58.7%
 - Calif doing great on UACR (37% HP goal) & DM education (62.5%)
