# Indian Health Services 2016 Best Practices Conference Health Concerns Among American Indians

- $\uparrow$  incidence of heart disease, cancer, accidents; diabetes, & stroke.
- $\uparrow$  prevalence/risk of mental health, substance abuse, & suicide.
- $\uparrow$  of sudden infant death syndrome (SIDS), & teenage pregnancy.
- $\uparrow$  liver disease, and hepatitis.
- $\uparrow$  Tb. rate 8 times greater than Caucasians.
- ↑ Cultural barriers; isolation; socioeconomic barriers.



# The Many Faces of Autism Spectrum Disorders




Autism ~all economic levels & races.
Parent's concerns often ignored.
Autism NOT caused by parenting.
Conditions ~ ASD: Mental Retardation (40%).
Behavioral Disorders (>80%).
Seizure Disorders (31%).

# What They Don't Teach In Medical School My "Top Ten List"

- 10. Having a child with disability or special needs is really tough.
- 9. Having a child with a disability strains **ALL** relationships.
- 8. How to care for a disabled child while spending the entire day either filling out forms and/or being placed on hold.
- 7. How to keep your child with autism from killing the cat, smashing furniture, and/or putting his head through he window while you're on hold and/or filling out forms.
- 6. How to maintain your sanity, when, after finishing the correct form and speaking to a real person, you're informed that there's a 6 month waiting list for the program.



#### What They Don't Teach In Medical School:

- 5. Whether your child qualifies for *program because of "eligibility" or "functional assessments."*
- 4. How to deal with "systems" that are: Not knowledgeable &/or Not Listening.
- *3. How to get information transferred from one program to another.*
- 2. That systems responsive to Autism will better all children ("Canary in the coal mine").
- 1. The number of dedicated & amazing individuals.

# Advocacy in Action: SB 946 (Steinberg) California Autism Insurance Mandate (2011)



**Problem**: Refusal of health plans to provide behavioral.

**SB 946:** Every health care plan that provides hospital, medical, or surgical coverage shall also provide coverage for behavioral health treatment for Autism Spectrum Disorders.

Results & Outcomes from SB 946 (March 2014):

- Eligible: 42,000 children (3-21 years of age).
- \$80 Million annual savings to DDS.
- \$200 Million annual savings to schools & taxpayers.
- Affordable Care Act.
- Medi-Cal coverage.

# Public Policy & Advocacy: "Rules of the Road"

Know your subject. Focus & brevity. Frame the issue & make it relevant. Tangible solutions. The first meeting is never the end. Pick your battles. Know your opposition; organize & be assertive. Alliances. Advocacy is for the long haul. Relationships, Relationships, & RELATIONSHIPS.

# What Makes Effective Advocacy?

- Focus on the issue, provide clear recommendations and goals
- Identify your target audience
- Use policy research and data effectively

to frame issue and support position

- Build strong coalitions
- Craft clear and concise messages
- Identify credible spokespeople
- Link to legislation and action





# The Art of Advocacy in the 21<sup>st</sup> Century

- Engagement of Youth.
- Quickly reach large number of people: Dissemination of information.
  - Event organization.
- Availability.
- Immediate, real-time communication.
- Compelling visuals.
- Unlimited time & space.
- Generate & focus resources.
