The committee has jurisdiction over customs, collection districts, and ports of entry and delivery; deposit of public moneys; general revenue sharing; health programs under the Social Security Act and health programs financed by a specific tax or trust fund; Social Security; reciprocal trade agreements; revenue measures relating to the insular possessions; tariffs and import quotas; and the transportation of dutiable goods.

FULL COMMITTEE

Jurisdiction: The panel oversees fisheries and wildlife, including research, restoration, refuges and conservation; forest reserves and national parks created from the public domain; forfeiture of land grants and alien ownership, including alien ownership of mineral lands; geological survey; international fishing agreements; interstate compacts relating to apportionment of waters for irrigation purposes; irrigation and reclamation, including water supply for reclamation projects and easements of public lands for irrigation projects; and acquisition of private lands when necessary to complete irrigation projects. It also oversees American Indians, including the care and allotment of Native American lands, general and special measures relating to claims that are paid out of Native American funds, relations of the United States with Native Americans and Native American tribes; insular possessions of the United States (except those affecting the revenue and appropriations); military parks and battlefields, national cemeteries administered by the Interior secretary, parks within the District of Columbia, and the erection of monuments; mineral land laws and claims; mineral resources of public lands; mining interests; mining schools and experimental stations; marine affairs, including coastal zone management (except for measures relating to oil and other pollution of navigable waters); oceanography; petroleum conservation on public lands and conservation of the radium supply in the United States; preservation of prehistoric ruins and objects of interest on the public domain; public lands, including entry, easements and grazing; and the Trans-Alaska Oil Pipeline (except ratemaking).

FULL COMMITTEE

Jurisdiction: The panel oversees interstate and foreign commerce, energy information and national energy policy. It has jurisdiction over biomedical research and development; consumer affairs and consumer protection; health and health facilities (except health care supported by payroll deductions); interstate energy compacts; exploration, production, storage, supply, marketing, pricing and regulation of energy resources, including all fossil fuels, solar energy and other unconventional or renewable energy resources; conservation of energy resources; the generation and marketing of power (except by federally chartered or federal regional power marketing authorities); the reliability and interstate transmission of, and ratemaking for, all power; and siting of generation facilities (except the installation of interconnections between government waterpower projects). The committee oversees general management of the Energy Department and management and all functions of the Federal Energy Regulatory Commission; public health and quarantine; regulation of the domestic nuclear energy industry, including regulation of research and development reactors and nuclear regulatory research; regulation of interstate and foreign communications; travel and tourism; and the committee shall have the same jurisdiction with respect to regulation of nuclear facilities and of use of nuclear energy as it has with respect to regulation of non-nuclear facilities and of use of non-nuclear energy.
