Dentrix Enterprise 8.0 Meaningful Use

1. Core Objectives

- Computerized provider order entry (CPOE) for medication, laboratory, and radiology orders (5.5 min)
- Generate and transmit permissible prescriptions electronically (eRx) (6.5 min)
- Record demographic information (3 min)
- Record and chart changes in vital signs (2 min)
- Record smoking status for patients 13 years old or older (3 min)
- Use clinical decision support to improve performance on high-priority health conditions (5.5 min)
- Provide patients the ability to view online, download, and transmit their health information (8 min)
- Provide clinical summaries for patients for each office visit (4 min)
- Protect electronic health information created or maintained by the Certified EHR Technology (2.5 min)
- Generate list of patients by specific conditions to use for quality improvement, reduction of disparities, research, or outreach. (4.5 min)
- Use clinically relevant information to identify patients who should receive reminders for preventive/follow-up care (4 min)
