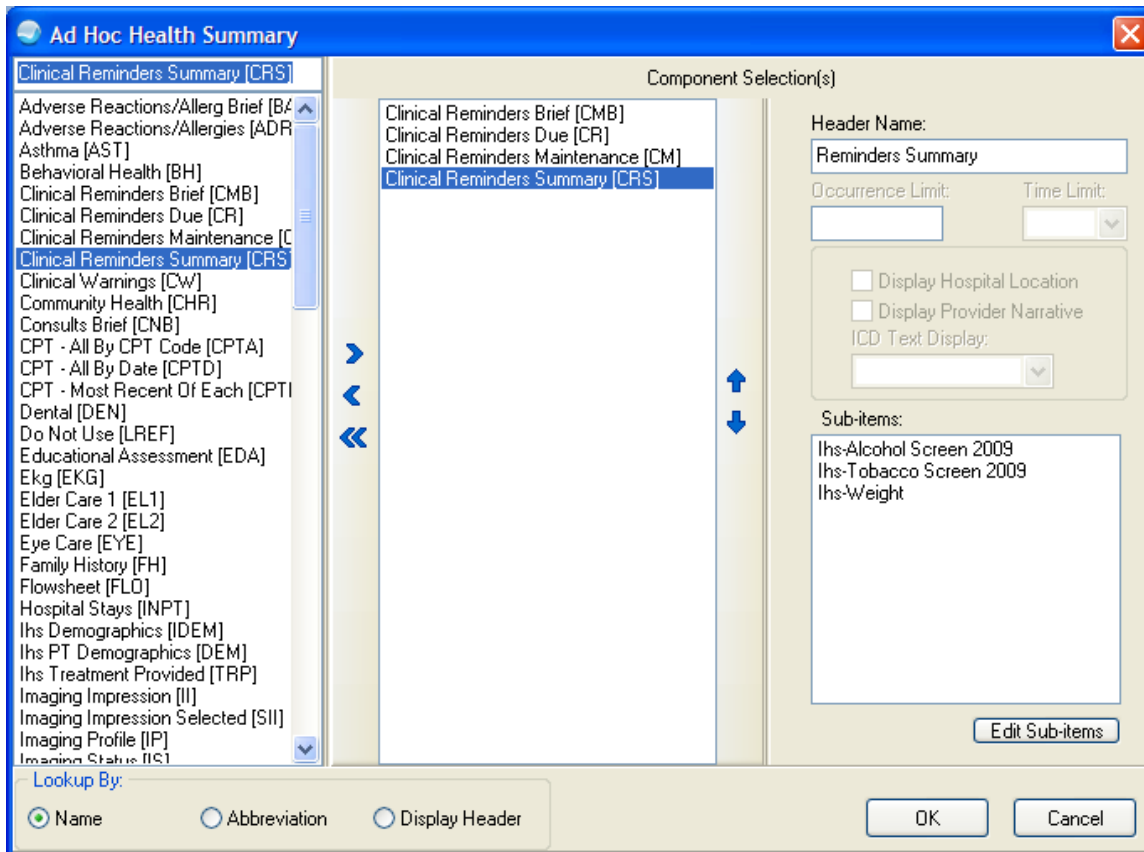
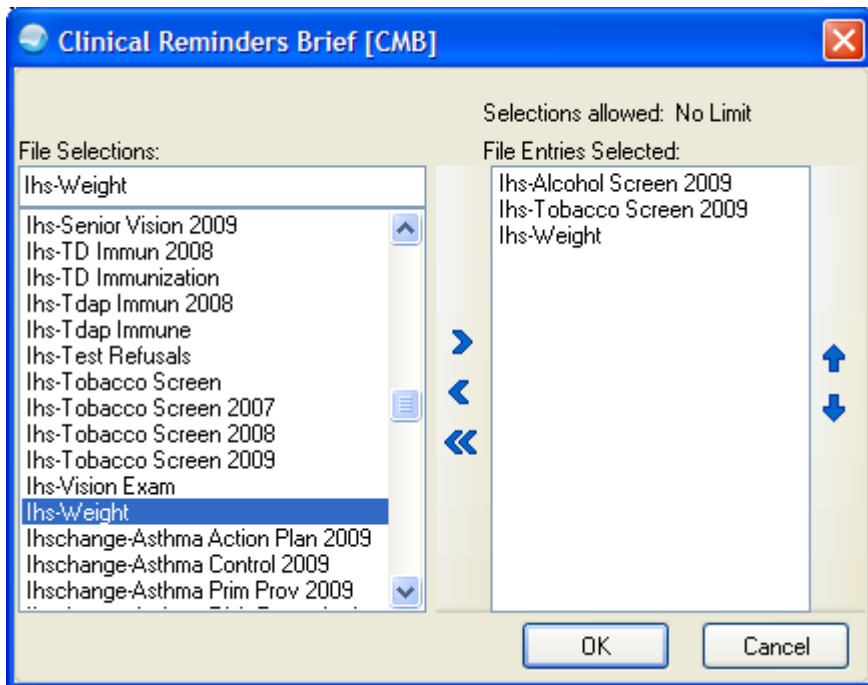
3. Using Ad Hoc Clinical Reminders Health Summary components
