### **Course Description**

The training will focus on providing knowledge on several topics including- pain management, aberrant behaviors, risk factors, opioid treatments, non-opioid treatments, non-pharmacological treatments, and pain prevalence. Case vignettes will use real-world examples of patient interactions and role-plays to learn how to address difficult issues and topics with patients.

- 1. Evaluate the epidemic of unintentional opiate overdose deaths.
- 2. Demonstrate the Institute of Medicine Guidelines for Best Practices in pain management.
- 3. Practice safe prescribing of opiate analgesics, with detailed equianalgesic dosing guidelines.

## **Presenters Bios**

**Joanna Katzman, MD, MSPH,** is Director of the University of New Mexico (NM) Pain Center and Project ECHO Pain, which received the 2011 American Pain Society Clinical Centers of Excellence Award. She is an Associate Professor at the UNM School of Medicine and currently resides on the New Mexico Governor's Council for "Prescription Drug Misuse, Overdose Prevention, and Pain Management". Dr. Katzman and her team at the UNM Pain Center collaborate with the IHS Telebehavioral Center of Excellence with their weekly teleECHO Pain and Addiction clinic as well as their Essential Trainings on "Best Practices Pain Management". She has directed the UNM Project ECHO Pain program for many years and formally collaborates with the Defense Health Agency to help them replicate teleECHO initiatives. Dr. Katzman has served on two Institute of Medicine (IOM) Committees related to the Gulf War and Health, and is the current President of the American Academy of Pain Management.

**Snehal Bhatt, MD,** is a board certified physician in General Psychiatry and Addiction Psychiatry. He is on faculty at the University of Mexico as the medical director for the Addictions and Substance Abuse Programs; a clinic serving over 800 patients with addictions, and co-occurring psychiatric illnesses. Additionally, he has been partnering with IHS Center for Telebehavioral Excellence and tribal programs to provide direct care, along with didactics and case consultations to clinicians across the nation. His current research projects include working with prisoners prior to their release in order to reduce recidivism rates, and studying the effects of psilocybin assisted psychotherapy as a treatment for alcoholism. His professional areas of interest include improving access to addictions treatment, managing co-occurring pain and addictive illnesses, teaching, and sociocultural elements of addictive illnesses and treatment.

**George Comerci, Jr., MD, FACP, ADAAPM,** is a Professor in the Department of Internal Medicine where he is actively involved in clinical care and teaching. He is also a consultant at the Pain Consultation and Treatment Center and the in Project ECHO Pain and Headache. He is an Advanced Diplomate of the American Academy of Pain Management and, with the help of several colleagues, has developed a curriculum for pain management intended for use by non-interventional physicians. This curriculum was released in 2013 and is available to any practitioner with an interest in improving the care of patients with chronic pain.

**Denise E. Taylor, MD,** received her doctorate from the University of Medicine. She completed pediatric residencies at Albert Einstein College of Medicine in New York and Tulane University School of Medicine in New Orleans and a physical medicine & rehabilitation residency at the Rusk Institute of Rehabilitation Medicine in New York. She received fellowship training in pediatric rehabilitation at George Washington University Children's National Medical Center. She joined the University of New Mexico Carrie Tingley Hospital in 2003 and is the Chief of the Pediatric Physical Medicine and Rehabilitation division and an Associate Professor in the Department of Pediatrics. Dr. Taylor is Board Certified in Physical Medicine and Rehabilitation, and in the subspecialty of Pediatric Rehabilitation Medicine.
