

Universe of Federal Spending




Budget Enforcement Act Categories

Created caps for discretionary spending, triggering sequester if exceeded.

Created "pay-as-you-go"
(PAYGO) rules for taxes and certain entitlement programs.




Authorizing Legislation




Annual Appropriations Act: Under the jurisdiction of the House and Senate Appropriations Committees, and typically provide funding for one fiscal year.

Authorizing Legislation: Under the jurisdiction of the other House and Senate Standing Committees, and can authorize and appropriate funding for one or more fiscal years.

Definitions

Discretionary Spending

OMB: Budgetary resources (except those provided to fund mandatory spending programs) provided in appropriations acts.

Definitions (cont.)

Appropriated Entitlements/Mandatory Appropriations

OMB: Classified as entitlements even though annually appropriated because authorizing statute obligates the U.S. to make payments

Definitions (cont.)

Entitlement Authority

OMB: The authority, generally provided by an authorizing statute, to make payments to persons or non-federal entities who meet the requirements established by law.

Definitions (cont.)

Mandatory Spending/Direct Spending


OMB: Spending controlled by laws other than appropriation acts (including spending for entitlement programs) and spending for the food stamp program. Mandatory spending is a more commonly used term than Direct Spending.
