PREFACE

This manual provides information regarding only the release and installation of the Health Summary Components package.

1.0 Release Notes

Health Summary Components is an adjunct application designed to allow Indian Health Service (IHS) summary components to be viewed and used in VA Health Summary types.

VA Health summary types may be used in TIU objects. In addition, the VA Health summary type –adhoc – allows a user to create and define a health summary on the fly.

Adding the IHS health summary components to VA health summary types allows these components to be used in the adhoc summary creation. VA Health Summary has components for progress notes, orders, and consults which are not available in the IHS health summary. By adding the Health summary components to the VA health summary, Indian Health should be able to access both types of components in one health summary.

Since all the components created will be part of the VA Health summary application, the user will need to be familiar with the following documents:

2.0 Installation Notes

Prefix: **bhs**

Current Version: **1.0**

Warning: Read entire notes file prior to attempting any installation.

2.1.1 General Information

- Make a copy of this distribution for offline storage.
- Print all notes/readme files.
- It is recommended that the terminal output during the installation be captured using an auxport printer attached to the terminal at which you are performing the software installation. This will insure a printed audit trail if any problems should arise.
- The Health Summary Components application has no menu options. It is a re-write of IHS health summary components so they can be used in GMTS Health Summary types

- FileMan v22 patch 1002 or higher
- Cache v4.1 or later
- GMTS v 2.7 patch 68 or later
- APCH v2.0 patch 13 or later
- XB/ZIB Utilities Version 3.0 patch 10 or later
- PCC Management Reports VERSION 3.0 patch 13 or later

3.0 Installation Instructions

3.1.1 Pre-Installation

No pre-installation preparation is necessary for the Health Summary Components package.

3.1.2 Installation

Under KIDS, load, and then install bhs_0100.k. Answer YES to all "Want to continue installing this build?" questions. Answer NO to all other Yes/No questions. The installation is a mega-build consisting of two builds Health summary components*1.0* and GMTS*2.7*1001.

3.1.3 Post-Installation

The process of adding items to the Ad hoc health summary is explained in this section.

The new components were not automatically added to the GMTS ad hoc health summary type. Since some of them are for inpatient care or may not apply to a site, it is better for each site to review the new components and determine which of them they wish to add to the ad hoc type.

3.1.3.1 Edit Ad Hoc Health Summary Type

Choose item 3 from the Health Summary Maintenance Menu.

3.1.3.2 Display Information

Choose whether or not to display the component if there is no data for the component.

3.1.3.3 Review Data

If desired, review the components already on the ad hoc summary.

3.1.3.4 Choose the Component to Add

1. SCHEDULED ENCOUNTERS
2. SCHEDULED ENCOUNTERS W/O W/INS ENC

CHOOSE 1-2: 2 SCHEDULED ENCOUNTERS W/O W/INS ENC

3.1.3.5 Enter Information for Component

What prompts appear depends on the type of component that has been selected

For a component that uses ICD9 codes, questions regarding what ICD text should appear will be asked.
