1.0 Introduction

Please review these changes and add a copy of them to any printed documentation your site may be using for the Clinical Reporting System version 7.0. These changes will be integrated into future versions of the software and user manuals and will no longer be considered an addendum at the time of the next release.

Patch 2 of the Clinical Reporting System version 7.0 contains the following changes:

- New GP8 menu option that allows sites to generate and export GPRA FY 2008 2nd quarter reports.
- New AGP8 menu option that allows Area offices to aggregate and report their Area GPRA FY 2008 2nd quarter reports.

Note: GPRA logic changes being integrated into CRS V8.0 are not included in these new reports. The GP8 and AGP8 reports are based on the logic used in the existing V7.0 GP and AGP reports. Only the hard-coded report date range has been updated. GPRA related logic changes will be released in CRS V8.0.

2.0 Change 1: GP8 Menu Option

The GP8 National GPRA report is the report sites will run to submit their 2nd quarter GPRA data to their respective Area offices for 2008 GPRA reporting until CRS version 8.0 is released. The hard coded date range for this report has been set to July 1, 2007- June 30, 2008 to allow preliminary GPRA reporting on FY 2008.

To run the GP8 report:

- 1. Type **RPT** at the "Select CRS 2007 Option:" prompt.
- 2. Type **NTL** at the "Select Reports Option:" prompt.
- 3. Type **GP8** at the "Select National GPRA Reports Option:" prompt.
- 4. Answer the report prompts as you would normally for the GP report.

3.0 Change 2: AGP8 Menu Option

The AGP8 National GPRA report is the report Area offices will run to aggregate their 2nd quarter GPRA data for 2008 GPRA reporting until CRS version 8.0 is released. The hard coded date range for this report has been set to July 1, 2007- June 30, 2008 to allow preliminary GPRA reporting on FY 2008.

To run the AGP8 report:

- 1. Type **AO** at the "Select CRS 2007 Option:" prompt.
- 2. Type AGP8 at the "Select Area Options Option:" prompt.
- 3. Answer the report prompts as you would normally for the AGP report.
