#### 1.0 Introduction

Please review these changes and add a copy of them to any printed documentation your site may be using for the Clinical Reporting System version 8.0. These changes will be integrated into future versions of the software and user manuals and will no longer be considered an addendum at the time of the next release.

Patch 1 of the Clinical Reporting System version 8.0 contains the following change applicable to this manual:

 Modified the Colorectal Cancer measure to move diagnosis code V76.51 back to the Colonoscopy definition from the Fecal Occult Blood Test definition and to add HCPCS G0106 and G0120 to the Double Contrast Barium Enema (DCBE) definition and refusal of DCBE definition.

#### 2.0 Patch 1

Patch 1 of the Clinical Reporting System version 8.0 contains the following change:

 Modified the Colorectal Cancer measure to move diagnosis code V76.51 back to the Colonoscopy definition from the Fecal Occult Blood Test definition and to add HCPCS G0106 and G0120 to the Double Contrast Barium Enema (DCBE) definition and refusal of DCBE definition.

### 2.1 Change 1

For Colorectal Cancer Screening, because of a significant decrease (~18%) in the 3<sup>rd</sup> quarter national IHS rate (reported with CRS 8.0) from the 2<sup>nd</sup> quarter rate (reported with CRS 7.0 Patch 1), two changes to logic were made. (1) Move POV V76.51 from fecal occult blood test (FOBT) definition (required every year) to colonoscopy (required once every 10 years). In CRS 8.0, this code was moved from colonoscopy to FOBT, which caused patients who ONLY had code V76.51 dated 2-10 years ago not to be counted in the GPRA measure. (2) Add CPTs G0106 and G0120 to double contrast barium enema (DCBE) definition. In CRS 8.0, these codes were removed from the DCBE definition, which caused patients who ONLY had one of these codes documented not to be counted in the GPRA measure.

The table below provides the updated CRS logic for colorectal cancer screening.
