1.0 Introduction

Please review these changes and add a copy of them to any printed documentation your site may be using for the Clinical Reporting System Version 9.0. These changes will be integrated into future versions of the software and user manual and will no longer be considered an addendum at the time of the next release.

Patch 1 of the Clinical Reporting System Version 9.0 contains the changes listed below. There are no changes to performance measure logic for any report.

- **Change 1:** Updated CRS graphical user interface (GUI).
- **Change 2:** Added new 2010 National GPRA & PART Report.
- **Change 3:** Added new 2010 GPRA & PART Forecast Patient List.
- **Change 4:** Added new 2010 Area Aggregate National GPRA & PART Report.
- **Change 5:** Fixed error occurring with transaction codes in the Osteoporosis Management topic in the Selected Measures (Local) Report.
- **Change 6:** Fixed a problem with incorrect display of overdue dates in the GPRA & PART Forecast Patient List.
- **Change 7:** Fixed a problem in the CRS GUI with display of patient list options.
- **Change 8:** Fixed a problem in the CRS roll and scroll with display of patient list options.
- **Change 9:** Fixed a problem in the CRS GUI with uploading of facility files at the Area Office.
- **Change 10:** Fixed a problem in the CRS GUI for the Create Search Template for National Patient List option.
- **Change 11:** Fixed a problem in the CRS GUI when viewing all CRS taxonomies in Taxonomy Setup.
- **Change 12:** Fixed a problem in the CRS GUI that allowed a user to delete a location in the site parameters.
- **Change 13:** Fixed a problem in the CRS GUI when a user created site parameters for a new location.

2.0 Patch 1 Changes

Patch 1 changes listed in the previous section are described in detail in the sections below.

2.1 Change 1

Updated the CRS graphical user interface (Visual CRS), which now contains all functionality included in CRS 2009 version 9.0 and version 9.0 Patch 1 and developed a more streamlined online help.

2.2 Change 2

In the National GPRA Reports menu; added menu option “GP10” that enables users to run the National GPRA & PART Report for the report period of July 1, 2009 – June 30, 2010 (GPRA year 2010) using the performance measure logic as it exists in CRS 2009 version 9.0. This report includes the tentative GPRA and PART 2010 performance measure targets.

For instructions on running this report, please follow the steps in the CRS version 9.0 User Manual, section 5.2.2 Running the National GPRA & PART Report except for step 5, type **GP10** to run the 2010 National GPRA & PART Report.

2.3 Change 3

Added menu option “FO10” that runs the GPRA & PART Forecast Patient List for the report period of July 1, 2009 – June 30, 2010 (GPRA year 2010) using the performance measure logic as it exists in CRS 2009 Version 9.0. Also updated the dates to reflect GPRA year 2010 in the text that describes how the measures can be met.

For instructions on running this report, please follow the steps in the CRS Version 9.0 User Manual, section 5.8.2 Running the GPRA & PART Forecast Patient List except for step 4, type **FO10** to run the 2010 GPRA & PART Forecast Patient List.

2.4 Change 4

Added menu option “AG10” that runs the Area Aggregate National GPRA & PART Report for the report period of July 1, 2009 – June 30, 2010 (GPRA year 2010) using the performance measure logic as it exists in CRS 2009 version 9.0.

For instructions on running this report, please follow the steps in the CRS version 9.0 User Manual, section 6.2.1 Area National GPRA & PART Report except for step 1, type **AG10** to run the 2010 Area National GPRA & PART Report.

2.5 Change 5

Fixed an issue with the look up of transaction codes in the Osteoporosis Management topic where the software was referencing the incorrect global name, which was causing an error to occur.

2.6 Change 6

Fixed a problem in the GPRA & PART Forecast Patient List for the Diabetes Nephropathy Assessment and Depression Screening topics where the date of the last screening and the overdue date were being displayed incorrectly. For Diabetes Nephropathy Assessment, this was occurring when the patient did not have an estimated GFR and a quantitative urinary protein assessment. For Depression Screening, this was occurring when the patient met the measure by having two mood disorder diagnoses.

2.7 Change 7

Fixed a problem in the CRS GUI where several patient list options were displayed that should not be when a user does not have the BGPZ PATIENT LISTS security key.

2.8 Change 8

Fixed a problem in the CRS roll and scroll where the Other National Measures Report Patient List option was displayed when it should not be when a user does not have the BGPZ PATIENT LISTS security key.

2.9 Change 9

Fixed a problem in the CRS GUI when Area Office users attempted to upload HEDIS facility files at the same time they were uploading other types of facility files, such as GPRA and ONM.

2.10 Change 10

Fixed a problem in the CRS GUI when a user selected two or more National GPRA patient lists that would be saved as search templates. The user was able to select multiple patient lists; however, when the user saved them to a search template, the GUI did not allow for each list to be saved to separate search templates. The GUI was changed to allow only one patient list to be selected at a time to be saved to a search template.

2.11 Change 11

Fixed a problem in the CRS GUI in Taxonomy Setup when a user clicked the “View All CRS Taxonomies” option. After the user selected a taxonomy to view and clicked the Close button, the GUI displayed a message stating items had been selected but not saved and asked the user to confirm they wanted to exit. This message should not have been displayed since no editing of taxonomies is allowed with this option, and the message has been removed.

2.12 Change 12

Fixed a problem in the CRS GUI in Site Parameters that allowed a user to delete a location and all of its site parameters. Because users are not allowed to delete a location in the roll and scroll, the GUI has been revised so that a user cannot delete a location.

2.13 Change 13

Fixed a problem in the CRS GUI in the Site Parameters section when a user created site parameters for a new location. The default community taxonomy and site’s home location parameters were incorrectly displaying the values for the division/facility that the user is logged into. The GUI has been fixed to leave these values blank.
