To install the final version of the outpatient pharmacy suite of software, Beta test sites need only do a routine restore (D ^%RR) of the following file: pso\_0600.r

## 1.0 Overview of the Outpatient Pharmacy Suite Installations

The Outpatient Pharmacy Suite consists of six individual operations described in each section of this guide that **MUST** be performed in the following order:

1. Outpatient Pharmacy Pre Version 6 Conversion

File Names: apsp0600.r

2. Outpatient Pharmacy V 6.0 File Names: pso\_0600.r (including PSO\*, PSN\*, VAD\* and APSP\*, and APSX, GMRA, APCHS7 namespaced routines)

3. IHS Outpatient Pharmacy V 6.0

4. National Drug File V 3.0

File Names: psn\_0300.g

5. Allergy Tracking V 3.0 6. IHS Outside Rx V 1.00 7. Tips for an Easy Conversion to V 6.0

**Note:** You should read this entire installation manual before attempting to install the pharmacy suite of software

## 2.0 Installation Notes for Pre Version 6 Conversion

**Prefix:** APSP

**Current Version:** 6.0

Very Important Note: One or two days before installing Outpatient Pharmacy, you will need to run a Pre-Version 6 Conversion Routine. This routine will check your PRESCRIPTION FILE for PROVIDERS that cannot be converted to the NEW PERSON FILE (200) because of a possible missing "A3" NODE in the old PERSON FILE (16) or if the provider field is set to null. A MAIL MESSAGE will be sent to the person running the routine. It will list the prescription number(s) and the provider name(s) that cannot be converted or it will state that all prescriptions can be converted. If the provider is set to null, the provider in the mail message is UNKNOWN.

If prescriptions cannot be converted, the prescription must be edited and the "A3" link needs to be set in the PERSON FILE (16). Instructions on how to edit prescriptions with bad pointers will be included in the mail message. After editing all prescriptions that cannot be converted, this routine must be run again to produce a mail message showing no conversion problems. A flag will also be set in a pharmacy parameter file that will allow your Outpatient V 6.0 inits to run.

### Remember:

You must run this routine ONE or TWO days before attempting to install Outpatient Pharmacy V 6.0. Also, other beta sites suggest you do a Global Save of the PSNDF global the day before you install the National Drug File. Doing so will save time on install day.

**Note:** This is VERY IMPORTANT. If Outpatient Pharmacy V 6.0 has been successfully installed on your system and the provider conversion ran to completion and your site was a Beta test site, you do not need to run it again! You may proceed with installing Outpatient Pharmacy V 6.0.

## 2.1 General Information

It is recommended that the terminal output during the installation be captured using an auxport printer attached to the terminal at which you are performing the software installation. This will insure a printed audit trail if any problems should arise.

## 2.2 Contents of Distribution

apsp0600.r - routine APSP61P

## 2.4 Requirements

The following software, programs and utilities must be installed before successful installation may begin: (1) Kernel V 8.0 or later, (2) FileMan V 21 or later, (3) Outpatient Pharmacy V 5.06 2.4.

## 2.5 Before You Begin: Installation Issues

The following provides information about the installation instructions for pre-version 6 conversion routine.

In all UCIs which will be running this Pre-Version 6 Conversion routine:

1. Although there is no need to disable logins, I recommend that this routine be queued to run during low user periods.
2. Do a routine restore from the file <apsp0600.r> which will restore routine (APSP61P). Enter command: D ^%RR
3. Set your key variables by entering the following commands:
  - a. At the programmer prompt enter D ^XUP <return>

- b. Enter your access code and press <return> twice.
4. Enter D ^APSP61P <return>

**Pre Verison 6 Conversion routine has been queued!**

**Check your mailbox in a while for a conversion notice!**

5. You should check your mail periodically for one of the following Pre-Version 6 Conversion messages:

All Providers who are authorized to write prescriptions MUST have an entry in the In the following fields in the New Person:

53.1 AUTHORIZED TO WRITE MED ORDER - Must be set to 'Yes" 53.5 PROVIDER CLASS - Must have a valid provider class

Your hospital Administrator can provide you with a list of current Providers.

Pharmacy will not be able to fill prescriptions issued by providers if this information Is missing.

Included in the 'Tips' section of this manual is an example of a "Search File Entries" which can setup using the FileMan Search option. It will provide a current list of all persons who have not been inactivated and are missing the above information.

### 3.0 Installation Notes for Outpatient Pharmacy

**Prefix:** PSO

**Current Version:** 6.0

Warning: Once you start the installation of the Outpatient Pharmacy Suite software you must completely install all packages in this suite. Logins MUST remain disabled !! **\*\*This is for Pharmacy Users Only\*\***  
Please make sure that you have sufficient disk space to backup the old PSNDF global and space available for the new global. Some systems may protect globals from being killed and require special permissions to allow you to do so.

1. To save time on the day of the install, do a global save of the National Drug File (PSNDF) and a routine save of PS\* and APSP\* namespace routines a day or two before the install date.
2. During the installation of the National Drug File you will be instructed to kill the PSNDF global and during the init process, the software also tries to kill the PSNVRT global. These globals may be protected, and must be unprotected first. Do this using ^%GCH.
3. Also, it would be wise to stop journalling until after the inits are done.
4. Make sure you print a copy of the following site parameters using the VA FileMan >INQUIRE TO FILE ENTRIES> before starting inits.
  - a. Pharmacy Site File (59)
  - b. IHS System File (sub-file Pharmacy System) (1800009)
5. When all Pharmacy users are off the system, record the last prescription number from the Prescription File (52). To do this, enter the following command and write the number in the 3rd piece of the 0 node of the ^PSRX global.

Example: D ^%G

6. Read the “Tips” section of the Installation Guide before starting the installation process.

**Note:** This is VERY IMPORTANT. It is strongly recommended that you do a DIFROM on your Pharmacy Site File (59) WITH data to create a set of routines in your own namespace which will allow you to recreate this file in the event that the initialization process does not complete. Doing this will allow you to restore your site file if necessary. I also recommend you do an 'Inquire to file entries' for all division(s) in your Pharmacy Site File so that you'll have a hard copy of your parameters if needed.

\* Running DIFROM can be done the same day that you will be installing Outpatient Pharmacy!

### 3.1 Example of DIFROM of File 59

1. At the programmer prompt enter D ^XUP <return>
2. Enter your access code and press <return>
3. Enter **D P^DI** and press <return>
4. Enter **D ^DIFROM** <return>
5. Enter the Name of the Package (2-4 characters): AZFM

**Note:** Your local name space can be chosen for the DIFROM. This is only a suggestion.

**Note:** Remove these routines from your system 7-10 days after this installation if no problems are noted with the new install.

## 3.2 General Information

It is recommended that the terminal output during the installation be captured using an auxport printer attached to the terminal at which you are performing the software installation. This will insure a printed audit trail if any problems should arise.

## 3.3 Contents of Distribution

pso\_0600.r - routines including PSO\*, PSN\*, VAD\*, APSP\*, APCHS7, APSX, and GMRA.

**Note:** VAD\* routines supply the interface between patient-related globals and outpatient pharmacy package. Some APSP\* and PSN\* routines are called by the PSO init routines, therefore, they must be loaded with the PSO\* routines.

### 3.4 Requirements

The following software, programs and files must be installed on the system before successful installation can begin: (1) Kernel V 8.0 or later, (2) FileMan V 21 or later, (3) Outpatient Pharmacy V 5.06 or later, (4) National Drug File V 2.0 including running the conversion rematch option within V 2.0., (5) The Outpatient Pharmacy Pre-Version 6 Conversion program in Section I.

### 3.5 Installation Instructions

In all UCIs which will be running the Outpatient Pharmacy (OutPharm), do the following:

1. Disable logins or ensure all users are off your system.
2. If you have previously installed OutPharm on your system you'll need to do a routine save of PS\* and APSP\* routines which you should already have if you loaded the Outpatient Pharmacy package. Enter command:

```
D ^%RS
Enter output device <HFS> <press return>
File Name: (use your local name space) <return>
Enter size of save medium (if applicable): <return>
Enter comment for dump header :PS* and APSP* routines V 5.06

Routine selector: PS*

**Note:** \*Saving PS\* and APSP\* now will save you from having to do so in other installs associated with this package. PS\* also includes all inpatient namespaced routines (i.e., PSJ\*, PSIV\*, and PSG\*).

\* Remove this routine save file from your system 7-10 days after installation if no problems noted with the new install.

3. Delete the old PSO\*, PSN\* and APSP\* V 5.06 routines.

### 3.6 Journaling: How to Stop and Re-start During the Installation Process

**Note:** Journaling Utilities may vary depending on the type of system your RPMS software is installed on!!! The following instructions are for sites running on IBM RISC systems.

Stopping and Re-Starting journaling in a UCI involves running two different utilities (JRNL and UCIMGR).

**CAUTION!!!** BE CAREFUL when you select these options and DO NOT modify other parameters!

To STOP the journaling process on your system you must do the following:

1. Switch to your Manager UCI from your production UCI by entering the following code:

a. D ^%ZUCI <return>

b. SWITCH TO NEW UCI

You are now in PRD,IHS. Note: Your production UCI name may be different.

c. Enter new UCI: MGR <return>

You have switched to MGR,IHS

2. Enter the Journal Utility: [MGR,SMA]>D ^JRNL <return>

5. Set your key variables by doing the following:
  - D ^XUP - Enter your access code and press <return> until you are back to the prompt.
  - D P^DI Press <return> back to the prompt.

1. GMRA-ALLERGY VERIFY - This key will be given to those personnel who will be able to verify allergy/adverse reactions.
2. GMRA-SUPERVISOR - This key will be given to those personnel who will be able to override the security in the Allergy System and allow editing of the data.

Option (GMRA SITE FILE) must be used to setup the site parameters for the Allergy Tracking System.

You may now review the IHS Outside Rx Installation Notes in Section VI. Do not enable logins until after you have completed all of the Outpatient Pharmacy Suite installations.

The GMRAI\* routines may be removed from your system after a successful installation.

## 7.0 Installation Notes for IHS Outside RX

**Prefix:** APSX

**Current Version:** 1.0

### 7.1 General Information

It is recommended that the terminal output during the installation be captured using an auxport printer attached to the terminal at which you are performing the software installation. This will insure a printed audit trail if any problems should arise.

### 7.2 Contents of Distribution

NOTE: APSX\* routines are included with the pso\_0600.r file.

### 7.3 Requirements

The following software, packages, products and utilities must be installed before successful installation may begin:

- Kernel V 8.0 or later,
- FileMan V 21 or later,
- Outpatient Pharmacy V 6.0,
- IHS Outpatient Pharmacy V 6.0

### 7.4 Installation Instructions

In all UCIs which will be running the IHS Outside Rx (ORX):

1. Disable logins or ensure all users are off your system.
2. No need to do a routine save (^%RS), routine delete (^%RDEL) or a routine restore (^%RR) of APSX routines. Total APSX routines = 10.
3. Set your key variables by doing the following:

D ^XUP - Enter your access code and press <return> until you are back at the prompt.

D P^DI - Press <return> back to the prompt.

6. Before enabling logins, I recommend that you do a 'Systems Status' and look for any background jobs related to the Outpatient Pharmacy Suite installations that may still be running. Enter command:

Enable logins after all background jobs are done.

The APSXI\* routines may be removed from your system after a successful installation (7 to 10 days after this installation if no problems are noted).

## 8.0 Tips for an Easy Conversion to Version 6.0

### 8.1 Note from the Developer

When you decide to install the Pharmacy Suite of software, I'd like to be notified in advance in order to provide you with technical support. You may contact me, Edgar Moore, the week before you plan to install at (505) 248-4357, or send me an e-mail message.

### 8.2 Before You Start The Installation Process

1. Study the entire Installation Guide a week before you want to install.
2. Make a hard copy of your current site parameters using FileMan "Print or Inquire to Files" options for the following files:

Outpatient Site (#59)

IHS System (#1800009)

3. Entries in these files must be re-created after the install finishes.

**Note:** Make a note of your last known prescription number before installation.

4. The National Drug File (NDF) V 2.0 must be installed, matched, verified and merged before loading this suite of software. Get started now if you have not already finished this.
5. Ensure that you have sufficient disk space on your system before starting the install.
6. Notify your users in advance of your plans to install this software.
7. There are two questions on pages V-2 and V-3 in the Allergy Tracking Install section that should be reviewed by your Pharmacist. The questions are:

This conversion will convert data from the Patient file and delete that data. ARE YOU SURE THIS IS OK? YES

If I convert any data you may have, would you like the converted data to be :

(1) Stored in the Allergy Tracking System already verified, or

(2) Stored in the Allergy Tracking System as Unverified?

Choose a number from 1-2

If you've received the User Manuals (Outpatient Manuals will be sent electronically in a PDF format. National Drug File and Allergy manuals will be hard copies), please make them available to your users for review

### 8.3 On the Day You Install

Follow the Outpatient Pharmacy Suite installation guide to the letter. Read and comply with every step, note and warning.

All pharmacy activity must be blocked (logins disabled) until all packages in this suite have been completely installed. The Outpatient Package relies on both the Allergy Tracking and the National Drug File packages. You will encounter many errors if users are allowed to log on too soon.

### 8.4 After All of the Installs are Done and Before You Enable Logins

Check and setup your parameters in the Outpatient Site and the APSP Control files for each division that will be accessing your system. See Attachment A.

Check if the "A" cross-reference exist in the new Medication Instruction file using the Global Lister Utility.

If the "A" cross-reference is not present the medication instructions (SIGs) will not expand on the Rx Labels. If this is the case, you will have to re-index this cross-reference using the FileMan Re-Index File option.

An “Outpatient Pharmacy” entry must be added to the Package field in the PCC Master control file so that your prescriptions will be passed to PCC.

This can be corrected by the Site Manager using FileMan to edit the New Person file (200). See Attachment B for a Search example.

Data from the IHS System file will now be stored in a new “APSP Control” file. You will have to make an entry in this file for each division that will be using your system. Besides all of the “label” parameters, there are also two new fields that must be set:

1. MANUFACTURER/LOT#/EXP -parameters for manufacturer information:
  - 1 ASK FOR AND DISPLAY ALL MANUFACTURER DATA
  - AS AND DISPLAY EXPIRATION DATA ONLY
  - DON'T ASK OR DISPLAY MANUFACTURER DATA
2. DEFAULT OTHER LOCATION - Used by the Outside Rx Module. This file points to the Location File.

The RX Patient Status File (#53) holds valid statuses and other parameters used by outpatient pharmacy. A Pharmacist should review the parameters in this file.

If your site is a multi-division site and you want to use a different Rx number range for each division, please contact the Pharmacy Supervisor.

## 8.5 After You Enable Logins

Average Wholesale Price (AWP) fields have been added to the Drug file and can be edited when you select “Drug Enter/Edit.”

Multi-Division sites must insure that all pharmacy users have the proper division(s) defined in the New Person File (#200).

Each Pharmacist must assign themselves an “Electronic Signature Code.”

Enter “TBOX” at any menu prompt and select “Electronic Signature code Edit.”

Several options/background jobs will need to be ran that will recompile and/or initialize different data for various reports.

(Maintenance Menu)

- Queue Background Jobs
- Recompile AMIS Data Go back as far as you need to.

(Supervisor Functions)

**Note:** Details on each of the above options may be found in the Outpatient Pharmacy User Manual.
