Content of Patch

Contents of Patch

- The goal of this patch is to create and populate a new global in the Clinical Reminders namespace, ^PXRMINDX, that is an index of clinical data.
- Each of the packages whose data Clinical Reminders uses as a finding type will be participating in this project.
- The indexes are also required for the graphing functionality in EHRp11.

Contents of Patch

This global consumes a large amount of disk space and requires a long time to initialize the cross-references.

- It is important to read the Global Size and Global Placement sections in the Pre-Installation section before installing this patch.
- When these patches are installed, the cross-references begin populating the ^PXRMINDX global on all new data.
- A separate initialization process populates old data.

SITE PREPARATION

Preparation for Installation

• It is imperative that the individual(s) installing the patch and/or indexing files read the patch documentation thoroughly BEFORE installing the patch.

Populate Mailman Group

- 1. Identify the Mailgroup used for reminder management using Fileman Inquire into File 800 (Clinical Reminder Parameters file)
- 2. Add your CAC and IT to the mailgroup

Calculate Size of the Global

PXRM 1.5 p1006 delivered a utility that will estimate the size of the global that is created when the files are indexed

From the Programmer Prompt EHR> **D ESTTASK^PXRMISE**

Calculate Size of Global

This will start a taskman job that estimates the initial size of the index for each global as well as total size.

The information will be delivered in a MailMan message sent to member of the Mail group defined in File 800.

- The size estimate is given in blocks. For Caché, they are 2K blocks and for DSM they are 1K blocks.
- Most sites will be using 8k blocks. If you are using 8K blocks to store the index global, you can multiply the predicted number of blocks by the above factors to get an estimate of the number of 8K blocks that will be used.
- This database will grow over time but this will give you the size of the initial globals.

Calculate Size of Global

For reference: Tampa VAMC is a hospital with a service population of >100,000 with a hospital and 4 ambulatory clinics

• Tampa VAMC grew from 20207 to 21010 MB in three months. They have split the index global across two volume-sets (due to the current 16 MB limit for DSM), each volume set having less than a 5% growth over the 3-month period. (However, when sites convert to Caché, the limitation on the volume set size is lifted.)

Global placement

- If you have Radiology 1003, you have the global placed already.
- If not, you may use global translation or global mapping to create a volume or data set, then place the ^PXRMINDX global, according to the instructions that are appropriate to your system.
- Consider placing ^PXRMINDX in its own volume set, setting the Cache dataset based on estimated sized + room for significant growth.

Journaling - "Historical Seeding"

- During creating and building of index, disable the journaling of ^PXRMINDX.
- You may enable it after the indexes have been created but do not have to.
- You may re-create the index. IF you re-create the file while indexing, the reminders will not work, so index during off hours.

POST INSTALLATION

Index Management

New option "PXRM INDEX MANAGEMENT"

- PXRM INDEX BUILD
 - Initially populates the indexes by indexing the existing data
 - The utility can be used to restore an index should it ever become corrupted
- PXRM INDEX COUNT
 - Provides a count by year of the entries in the index
 - Allows sites to see how the data is distributed on a yearly basis

Index Management

- May build interactively or as tasked job
- May take a while minutes to hours depending on the size – lab is the largest
 - PIMC 15 hours to run lab index
- Should be run when there are minimal users on system

Files to Index

- Required for Enhanced Graphing and Reminders 2.0
- Lab must be indexed for Graphing to be initiated

After indexing is completed, members of Mail group defined in File 800 will receive a mailman message similar to this:

Indexing Errors

If any entries could not be indexed, the completion message will look similar to this:

Indexing Errors

Another MailMan message contains the information for the last "N" errors starting with most recent to oldest. "N" is set in file 800 and is defaulted to 200.

Clean Up Recommendations

You may have some indexing errors. The most common will be inpatient orders and these can be ignored as they are not generally used for reminders.

Inpatient Pharmacy developers agree that there will be many of these.



PAP for 30-64yo

Applicable: Due every 5 years for ages 30Y to 64Y within cohort.

REMINDER DUE: For females aged 30-64 with intact cervix if no PAP test in past 3 years OR

if no PAP test AND HPV test documented in past 5 years

*** Reminder Frequency is set to 5 years. When PAP is performed without HPV, the PAP expires in 3 years and will show due once it has been 3 years since the PAP was performed ***

Example:

- Woman is 32 with intact uterus.
- Had PAP *only* on 2/1/2011
- Her Reminder will show Next Due on 2/1/2016
- On 2/2/2014 her PAP will "expire" and be Due Now (because she did not have an HPV also)
