## Preface

This documentation applies to information distributed in patch 1009 of Clinical Reminders. This patch installs cross-references for certain V files and allows the building of the Clinical Indexes needed for Reminders Version 2.0 and for the new graphing capabilities of EHR patch 11

The indexes are built as new-style cross-references on reminder files. These cross-references then create an index file in the database that is used for data retrieval. The index file is NOT a FileMan file so it cannot be accessed in the usual way.

When this patch was released in the VA, it was a combined patch so that after installation all the indexes could be created. Indian Health does not usually make combined patches and because of that, the indexes themselves are distributed in several patches.

This patch only contains the indexes for the PCC related files (V files). This file also contains the menus and options to do the indexing for ALL the indexed files.

The remaining indexes are in the following patches

- The Radiology cross-reference is distributed in the RA\*5.0\*1003
- The Pharmacy cross-references are in the EHR Patch 11 MegaBuilds
- The Orders cross-references are in the EHR Patch 11 MegaBuilds
- The Problem List cross-references are in the EHR Patch 11 MegaBuilds
- The Laboratory cross-references are in the LR\*5.2\*1031 build

You cannot build the indexes on these files until these builds are installed. These new indexes are required to be built for reminders version 2.0, but can be built any time prior to that date.

## 1.0 Introduction

The goal of this patch is to create and populate a new global in the Clinical Reminders namespace, ^PXRМINDX, that is an index of clinical data. Each of the packages whose data Clinical Reminders uses as a finding type will be participating in this project.

**Note:** This global consumes a large amount of disk space and requires a long time to initialize the cross-references. It is important to read the *Global Size* and *Global Placement* sections in the *Pre-Installation* section before installing this patch. When these patches are installed, the cross-references begin populating the ^PXRМINDX global on all new data. A separate initialization process populates old data.

### 1.1 Indexes included in PXRМ\*1.5\*1009

These indexes can be created any time after this patch is installed. It is always recommended that indexing be done one index at a time. Large files like the Purpose of visit (VPOV) may take many hours to index.

If you start index creation before installing EHR Patch 11, keep an account of which files have been done and which ones you still need to do.

Lab and radiology indexes have been distributed in separate patches. The rest are part of EHR patch 11. Please be aware that the graphing capabilities of EHR patch 11 cannot be utilized until the lab index is created.

This patch will encompass the PCC files and the menus/options to create the new indexes.

**Note:** When PXRМ\*1.5\*1009 is installed, it creates a new-styled AED cross-reference, and populates the index in the V Health Factors file. If your site has a large number of entries in their file, it can take a while - and a large amount of CPU resources – for the index to build. The following messages appear while this happening:

Creating V Health Factor AED cross-reference

The installation will pause while the index is being populated

If you have a large V Health Factor file this could take a while

The indices will start storing data as soon as this patch is loaded because the cross-reference(s) included will be fired with each new V file entry.

## 2.0 Pre-installation

### 2.1 Required Software

Make sure all required RPMS software is installed.

#### 2.1.2 Patch Dependencies

All of these dependencies should be met if the site has installed kernel patch 1017, PIMS patch 1015, EHR patch 10 and PXRМ patch 1009. The VA has many cross-application dependencies especially for clinical reminders since they incorporate data from so many different files. The list below is only provided if the patch fails on install and the site manager needs to check and see if a particular patch is in their system.

## 2.2 Populate Mailman Group

Identify the Mailgroup used for reminders management using the FileMan Inquire into file 800 (Clinical Reminders Parameter file).

Add your Clinical Applications Coordinator and IT to the mailgroup if needed.

Make sure this mailgroup is set up. It will contain any errors on indexing and information when an index is completed.

## 2.4 Global Placement

Since this global serves as an index for the clinical data in several packages, it is independent of a particular package. When new data is entered into the globals being indexed, the index grows, so it must be placed where it has room to expand.

Use global translation or global mapping to create a volume or data set, then place the ^PXRМINDX global, according to the instructions that are appropriate to your system, as described below.

### 2.4.1 Ensemble (Caché)/VMS Sites

The developers recommend placing ^PXRМINDX in its own volume set. The initial size of the Ensemble (Caché) dataset should be based on the estimated size, plus leaving room for significant growth.

Once the new dataset has been created and mounted, a new entry for the PXRМINDX global must be added to the Global Mapping section in the Caché Configuration Manager for each running Caché configuration and activated (for example, Configuration Manager\Namespace\VAH\Global Mapping).

**Note:** For Ensemble sites, each running Ensemble configuration in the Cluster must be updated. It is **IMPORTANT** that each Ensemble configuration be updated; otherwise, unpredictable results can occur.

After the Global Mapping has been updated, create the PXRМINDX global:

1. Log on to the RPMS namespace
2. From the programmer mode prompt, issue the following command:

```
S ^PXRМINDX=""
```

It is highly recommended to perform the Ensemble steps without users on the system and **PRIOR** to the installation of the CLINICAL\_REMINDERS\_INDEX.KID build.

## 2.5 Journaling

### 2.5.1 During Historical Seeding – Disable

Once the PXRМINDX global is created, the historical seeding of the index can begin by using the options on the PXRМ INDEX MANAGEMENT menu. For this historical seeding, it is **HIGHLY** recommended that journaling of ^PXRМINDX be **DISABLED**. During the initial creation and building of the index, journaling is not recommended because the index is not in use by the application, and it can be rebuilt if necessary. In addition, there are concerns about journal files filling up with the large volume of SET commands that occur during the historical seeding of the PXRМINDX global. Due to these factors, it is recommended that journaling be disabled on the PXRМINDX global until the historical index seeding is completed.

### 2.5.2 After Historical Seeding is Completed – Enable

Once the options on PXRМ INDEX MANAGEMENT menu are completed, enable journaling of the PXRМINDX. The PXRМINDX index global will grow and will be utilized by Clinical Reminders Version 2.0 application when released. If the PXRМINDX global becomes corrupted, it can be rebuilt but the amount of time needed to rebuild the index will impact users of Clinical Reminders application. It is the recommendation that if the index needs to be rebuilt, it is safer and more efficient to journal the index once the initial build and historical seeding are completed.

### 2.5.3 Post-Installation

Refer to Section 2.6 for information on how to build the index and for programming information.

### 2.5.4 Error Messages

If there were errors during the building of the index, a MailMan message will be created that gives details about the entries that could not be indexed. The number of entries that cannot be indexed may number in the thousands for the Prescription file and the Pharmacy Patient file.

This may be a result of bad data at the local sites or system errors. It may indicate data that is missing in application files, and may require local site investigation and correction. The majority of the messages received at test sites have referred to old data that won't affect reminder validity, but may affect reminder report validity (e.g., long-term retrospective ones).

If you receive these error messages, we recommend that you coordinate with local CACs to determine the causes and corrective actions, if necessary.

Each site needs to look at a sample of the error messages to determine if the data needs to be cleaned up or ignored.

## 2.6 Index Management Menu (PXRM INDEX MANAGEMENT)

When PXRM\*1.5\*12 (contained in PXRM\*1.5\*1009) is installed, it creates a new option, PXRM INDEX MANAGEMENT, which is a menu containing PXRM INDEX BUILD and PXRM INDEX COUNT. The index building utility serves two purposes:

- It initially populates the indexes by indexing the existing data. It works its way through the entire global, putting entries in the index for each piece of unique patient data it finds.
- If the index ever gets corrupted or destroyed, the utility can be used to rebuild the index.

Therefore, it is not necessary to journal the index, since it can be recreated from the original data at any time. However, we do recommend journaling, as described earlier in this document.

When the index utility finishes indexing a particular global, it sets the following three (3) nodes:

- `^PXRMINDX(FILE NUMBER,"GLOBAL NAME")=$GET1^DID(FILE NUMBER,"","","GLOBAL NAME")`

- ^PXRМINDX(FILE NUMBER,"BUILT BY")=DUZ
- ^PXRМINDX(FILE NUMBER,"DATE BUILT")=\$\$NOW^XLFDТ

In addition to providing information about who built the index and when it got populated, these nodes can be used to determine when the index is complete and ready for use.

When data is added, edited, or deleted, the indexes are kept current using new-style Mumps cross-references. These cross-references call APIs that set and kill the index entries.

## 2.7 PXRМ INDEX BUILD

The index build utility can be accessed through the option PXRМ INDEX MANAGEMENT or directly via PXRМ INDEX BUILD.

Select OPTION NAME: PXRМ INDEX BUILD.

### 2.7.1 Select Index

Indexes for each of the globals can be built or rebuilt in any combination desired.

You can run the build interactively or as a tasked job. Since these can take quite a while, they should be run when there are minimal users on the system, and should probably be done one at a time. Do NOT begin indexing the same day as EHR 11 installation. It is suggested that you wait about one (1) week and then begin to create the indexes one at a time. However, if PXRМ\*1.5\*1009 is installed in advance of EHRv1.1p11, selected indexes may be built ahead of the install of EHRv1.1p11.

Once an index is built and Reminders 2.0 is running, rebuilding an index causes the reminders using that index to be unavailable. Rebuilding an index, if necessary, should always be done after hours.

The indexes are required to be built before Reminders 2.0 can be installed. They are also required for graphing changes which are delivered in EHRv1.1p11.

After selecting the globals to be indexed, you will be given the choice of submitting a tasked job or running it interactively. In either case, when the index build completes, members of the mail group defined in file #800 will be sent a MailMan message that looks something like:

**Note:** If the person who builds the indexes is not a member of the mail group, the messages will not be delivered to the members of the mail group, unless it is a public mail group.

If you select a list of globals to be indexed, they will be indexed sequentially, and if it is tasked out, only one task will be created. If, on the other hand, you select a global and task it out and then go back and select another global and task it out, you could have two concurrent jobs both trying to write to PXRМINDX at the same time. Some simple testing revealed that the total time for two concurrent jobs is longer than for two sequential jobs.

For example, we built the index for ORDERS and V CPT in a test account. Building them sequentially, ORDERS required 19:48 and V CPT required 19:19, for a total time of 1 15:07. When they were built concurrently, ORDERS required 1 15:58 and VCPT required 1 11:00, for a total time of 3 02:58, considerably longer than 1 15:07. Based on this data, the recommendation is to build the indexes sequentially, not concurrently.

It is highly recommended that sites index the items one at a time over a period of a couple of weeks. Many indexes cannot be built until after EHR patch 11 is installed and should NOT be indexed on the same day as EHR 11 installation. Indexes are NOT required until Reminders 2.0 is released but are desirable for graphing.

## 2.7.2 Error Messages

If any entries could not be indexed, the completion message will look something like the following:

Another MailMan message contains the error information for up to the last N errors. The error information starts with the most recent entry in the global that has an error and progressively works back toward older entries. The number of errors displayed, N, is a site-configurable parameter. The parameter is stored in the CLINICAL REMINDERS PARAMETERS file, #800, in the field MAXIMUM NUMBER OF INDEX ERRORS, field #15. The default value is 200. If you wish to change this, you can use the ENTER OR EDIT FILE ENTRIES FileMan option. If you find a substantial number of errors, it is likely there is a systematic problem, so after determining the cause and solution for the first few errors, you can probably apply the same corrective action to the bulk of them.

The message has the format: global, entry identification, and error message. The error message describes the problem – for example, missing or invalid data. Here is a sample of errors you might see for file #55:

The entry information identifies the exact entry in the global that could not be indexed. If we examine the last line, it tells us that for ^PS(55,10,"IV",32,0), there is no stop date, so it can't be indexed. If you are not familiar with the structure of the global being indexed, it will be helpful to have a data dictionary listing on hand to help you interpret the entry identification information.

Entries that are not index-able will never be found by any application that uses the index to find data. Each site should make a decision concerning what they want to do about non-index-able entries. Some recommendations can be found below.

## 2.8 Clean-up Recommendations

### 2.8.1 Inpatient Pharmacy

Test sites reported that most of the errors are the same type: missing start date or missing patient.

Inpatient Pharmacy developers agree that there will be many of these. A former bug in the application caused those entries that have an E on the end.

However, inpatient medications are deleted when the patient is discharged and should not have lasting effects on most reminders.

## 2.8.2 Outpatient Pharmacy

Pharmacy developers recommend that the entry should be skipped if certain data elements are missing that are required (for example, dfn of patient, zero node, drug, etc). As noted above, entries that are non-index-able will automatically be skipped by applications using the index.

What this means is that there will be data in the pharmacy files that are not in the indexes to be used for reminders. Most of them do not have all the data required for a good entry so they are invalid. As an example, if an entry in the prescription file has no data in the patient field, how would you ever know who that prescription belonged to? In that case, this entry is not in the index.

## 2.9 PXRМ INDEX COUNT Utility

The index count utility can be accessed through the option PXRМ INDEX MANAGEMENT or directly via PXRМ INDEX COUNT. This utility provides a count by year of the entries in the index. This will let sites see how their data is distributed on a yearly basis.

The selection for the count utility is identical to the build utility and the results are sent in a MailMan message just like the results of the build utility.

### 3.1 Inpatient Pharmacy

The index is on file 55, Pharmacy Patient. The structure is:

Microbiology and Anatomic Pathology data are stored in a complex hierarchy. The ITEM is therefore a compound expression. This allows single elements of data to be easily found. The DAS also depends on the type of lab data. A chemistry test result has four semicolon pieces.

Microbiology and Anatomic Pathology can be more complex and have a much more nested structure.

The API to retrieve the associated data is:

Where ICD0 is a pointer to the ICD Operation/Procedure file and ICD9 is a pointer to the ICD Diagnosis file. Because ICD 0 codes are stored at 10 different locations, five on the surgery node and five on the procedure node and ICD 9 codes are stored at 25 different locations, 10 on the discharge node, 5 on node 71, and 10 on the movement node, the storage node information is stored in the index. This allows quick retrieval from specific nodes.

For example, one of the ICD 9 codes is stored as DXLS, so in this case the string DXLS is the node subscript. Some of the ICD 9 storage nodes have names like secondary diagnosis 1, secondary diagnosis 2 etc, the corresponding nodes would be D SD1, D SD1. Movement storage nodes have names like M ICD2. The API to retrieve the associated data is PTF^DGPXRМ(DAS,.DATA).

**Note:** For some of the cross-references in PTF, TYPE OF RECORD is included in the list of fields. It is used to exclude entries whose TYPE OF RECORD is CENSUS from the index.



The API is documented in DBIA #3817.

## 4.0 Cross-References

The index is kept current by using new-style FileMan cross-references that fire whenever data is added, edited, or deleted. The cross-references are added to the respective packages' data dictionaries when the multi-package build PXRМ\*1.5\* is installed. A list of the cross-references that are added follows.

**Note:** Some of the packages do direct sets of the data into their globals instead of using FileMan. In those cases, the routines where the data is set or killed have been modified to call the package API that does the set or kill of the index entry.

### 4.1 LAB

Lab results are stored in the Lab Data file #63. This is a very hierarchical file with a strong dependence on the data dictionary.

The Lab package makes programming calls to update the ^PXRМINDX indexes. Chemistry-type data updates the indexes when results are verified. Anatomic Pathology and Microbiology update indexes when results are reported and/or released. Any changes to existing lab data update the indexes. All indexes are set using SLAB^LRPX and killed using KLAB^LRPX.

#### 4.1.1 Routines

Chemistry-type data updates in a central routine.

LRVER3A Chemistry data are updated on verification and editing of verified data. All transactions go through LRVER3A, which stores the results and sets all the cross-references. This routine calls CHSET^LRPX.

LROC It is very rare but chemistry data may be purged during purging of old orders and accessions. This only happens on data that is corrupted and not reportable. This routine calls CHKILL^LRPX.

All Microbiology and Anatomic Pathology data are updated using the same routine, UPDATE^LRPXRМ. Adding, editing, or deleting data invokes this call. Results are compared before and after editing. Any change will update the indexes. This routine is called from several routines:

- LRAPDA
- LRAPDSR
- LRMIEDZ
- LRMIEDZ2

- LRMISTF1
- LRMIV
- LRMIV1
- LRMIV2

Anatomic Pathology uses these routines to change the indexes:

LRAPDA, LRAPDSR, LRAPM, LRAPMRL, LRAPRES

Microbiology uses these routines to change the indexes:

LRMIEDZ, LRMIEDZ2, LRMINEW1, LRMISTF1, LRMIV, LRMIV1, LRMIV2, LRMIVER1

#### 4.1.2 Lab Indexes

This index collates results by collection date/time regardless of the section; again, making retrieval faster.

- Retrieve information for someone who does not have authority to access the information.
- Access, research, or change any user account, file, directory, table, or record not required to perform your OFFICIAL duties.
- Store sensitive files on a PC hard drive, or portable devices or media, if access to the PC or files cannot be physically or technically limited.
- Exceed their authorized access limits in RPMS by changing information or searching databases beyond the responsibilities of their job or by divulging information to anyone not authorized to know that information

#### 6.1.2 Logging On to the System

RPMS Users shall:

- Have a unique User Identification/Account name and password.
- Be granted access based on authenticating the account name and password entered.

- Be locked out of an account after five (5) successive failed login attempts within a specified time period (for example, one hour).

### 6.1.3 Information Accessibility

RPMS shall restrict access to information based on the type and identity of the user. However, regardless of the type of user, access shall be restricted to the minimum level necessary to perform the job.

Users Shall

- Access only those documents they created and those other documents to which they have a valid need-to-know and to which they have specifically granted access through an RPMS application based on their menus (job roles), keys, and FileMan access codes. Some users may be afforded additional privileges based on the function they perform such as system administrator or application administrator.
- Acquire a written preauthorization in accordance with IHS policies and procedures prior to interconnection to or transferring data from RPMS.
- Behave in an ethical, technically proficient, informed, and trustworthy manner.
- Logout of the system whenever they leave the vicinity of their PC.
- Be alert to threats and vulnerabilities in the security of the system.
- Report all security incidents to their local Information System Security Officer (ISSO)
- Differentiate tasks and functions to ensure that no one person has sole access to or control over important resources.
- Protect all sensitive data entrusted to them as part of their government employment.
- Shall abide by all Department and Agency policies and procedures and guidelines related to ethics, conduct, behavior and IT information processes

### 6.1.4 Accountability

Users Shall:

- Behave in an ethical, technically proficient, informed, and trustworthy manner.
- Logout of the system whenever they leave the vicinity of their PC.
- Be alert to threats and vulnerabilities in the security of the system.
- Report all security incidents to their local Information System Security Officer (ISSO)

- Differentiate tasks and functions to ensure that no one person has sole access to or control over important resources.
- Protect all sensitive data entrusted to them as part of their government employment.
- Shall abide by all Department and Agency policies and procedures and guidelines related to ethics, conduct, behavior and IT information processes.

### 6.1.5 Confidentiality

Users Shall:

- Be aware of the sensitivity of electronic and hardcopy information, and protect it accordingly.
- Store hardcopy reports/storage media containing confidential information in a locked room or cabinet.
- Erase sensitive data on storage media, prior to reusing or disposing of the media.
- Protect all RPMS terminals from public viewing at all times.
- Abide by all HIPAA regulations to ensure patient confidentiality

Users Shall Not:

- Allow confidential information to remain on the PC screen when someone who is not authorized to that data is in the vicinity.
- Store sensitive files on a portable device or media without encrypting.

### 6.1.6 Integrity

Users Shall:

- Protect your system against viruses and similar malicious programs.
- Observe all software license agreements.
- Follow industry standard procedures for maintaining and managing RPMS hardware, operating system software, application software, and/or database software and database tables.
- Comply with all copyright regulations and license agreements associated with RPMS software.

Users Shall Not:

- Violate Federal copyright laws.
- Install or use unauthorized software within the system libraries or folders.
- Use freeware, shareware or public domain software on/with the system without your manager's written permission and without scanning it for viruses first

### 6.1.7 Passwords

Users Shall:

- Change passwords a minimum of every 90 days.
- Create passwords with a minimum of eight characters.
- If the system allows, use a combination of alpha, numeric characters for passwords, with at least one uppercase letter, one lower case letter, and one number. It is recommended, if possible, that a special character also be used in the password.
- Change vendor-supplied passwords immediately.
- Protect passwords by committing them to memory or store them in a safe place (do not store passwords in login scripts, or batch files.
- Change password immediately if password has been seen, guessed or otherwise compromised; and report the compromise or suspected compromise to your ISSO.
- Keep user identifications (ID) and passwords confidential

Users Shall Not:

- Use common words found in any dictionary as a password.
- Use obvious readable passwords or passwords that incorporate personal data elements (e.g., user's name, date of birth, address, telephone number, or social security number; names of children or spouses; favorite band, sports team, or automobile; or other personal attributes).
- Share passwords/IDs with anyone or accept the use of another's password/ID, even if offered.
- Reuse passwords. A new password must contain no more than five characters per 8 characters from the previous password.
- Post passwords.
- Keep a password list in an obvious place, such as under keyboards, in desk drawers, or in any other location where it might be disclosed.
- Give a password out over the phone.

### 6.1.8 Backups

Users Shall:

- Plan for contingencies such as physical disasters, loss of processing, and disclosure of information by preparing alternate work strategies and system recovery mechanisms.
- Make backups of systems and files on a regular, defined basis.

- If possible, store backups away from the system in a secure environment

Users Shall Not:

- Violate Federal copyright laws.
- Install or use unauthorized software within the system libraries or folders.
- Use freeware, shareware or public domain software on/with the system without your manager's written permission and without scanning it for viruses first.

### 6.1.9 Reporting

Users Shall:

- Contact and inform your ISSO that you have identified an IT security incident and you will begin the reporting process by providing an IT Incident Reporting Form regarding this incident.
- Report security incidents as detailed in IHS SOP 05-03, Incident Handling Guide

Users Shall Not:

- Assume that someone else has already reported an incident. The risk of an incident going unreported far outweighs the possibility that an incident gets reported more than once.

### 6.1.10 Session Time Outs

RPMS system implements system-based timeouts that back users out of a prompt after no more than 5 minutes of inactivity.

Users Shall:

- Utilize a screen saver with password protection set to suspend operations at no greater than 10-minutes of inactivity. This will prevent inappropriate access and viewing of any material displayed on your screen after some period of inactivity.

Users Shall Not:

- Utilize a screen saver with password protection set to suspend operations at no greater than 10-minutes of inactivity. This will prevent inappropriate access and viewing of any material displayed on your screen after some period of inactivity.

### 6.1.11 Hardware

Users Shall:

- Avoid placing system equipment near obvious environmental hazards (e.g., water pipes).
- Keep an inventory of all system equipment.



- Keep records of maintenance/repairs performed on system equipment

Users Shall Not:

- Do not eat or drink near system equipment

### 6.1.12 Awareness

Users Shall:

- Participate in organization-wide security training as required.
- Read and adhere to security information pertaining to system hardware and software.
- Take the annual information security awareness.
- Read all applicable RPMS Manuals for the applications used in their jobs.

### 6.1.13 Remote Access

Each subscriber organization establishes its own policies for determining which employees may work at home or in other remote workplace locations. Any remote work arrangement should include policies that:

- Are in writing.
- Provide authentication of the remote user through the use of ID and password or other acceptable technical means.
- Outline the work requirements and the security safeguards and procedures the employee is expected to follow.
- Ensure adequate storage of files, removal and non-recovery of temporary files created in processing sensitive data, virus protection, intrusion detection, and provides physical security for government equipment and sensitive data.
- Establish mechanisms to back up data created and/or stored at alternate work locations.

Remote Users Shall:

- Remotely access RPMS through a virtual private network (VPN) whenever possible. Use of direct dial in access must be justified and approved in writing and its use secured in accordance with industry best practices or government procedures

Remote Users Shall Not:

- Disable any encryption established for network, internet and web browser communications

## 6.2 RPMS Developers

Developers Shall:

- Always be mindful of protecting the confidentiality, availability, and integrity of RPMS when writing or revising code.
- Always follow the IHS RPMS Programming Standards and Conventions (SAC) when developing for RPMS.
- Only access information or code within the namespaces for which they have been assigned as part of their duties.
- Remember that all RPMS code is the property of the U.S. Government, not the developer.
- Shall not access live production systems without obtaining appropriate written access, shall only retain that access for the shortest period possible to accomplish the task that requires the access.
- Shall observe separation of duties policies and procedures to the fullest extent possible.
- Shall document or comment all changes to any RPMS software at the time the change or update is made. Documentation shall include the programmer's initials, date of change and reason for the change.
- Shall use checksums or other integrity mechanism when releasing their certified applications to assure the integrity of the routines within their RPMS applications.
- Shall follow industry best standards for systems they are assigned to develop or maintain; abide by all Department and Agency policies and procedures.
- Shall document and implement security processes whenever available

Developers Shall Not:

- Write any code that adversely impacts RPMS, such as backdoor access, Easter eggs, time bombs, or any other malicious code or make inappropriate comments within the code, manuals, or help frames.
- Grant any user or system administrator access to RPMS unless proper documentation is provided.
- Not release any sensitive agency or patient information.

## 6.3 Privileged Users

Personnel who have significant access to processes and data in RPMS, such as, system security administrators, systems administrators, and database administrators have added responsibilities to ensure the secure operation of RPMS.

## Privileged Users Shall:

- Verify that any user requesting access to any RPMS system has completed the appropriate access request forms.
- Ensure that government personnel and contractor personnel understand and comply with license requirements. End users, supervisors, and functional managers are ultimately responsible for this compliance.
- Advise the system owner on matters concerning information technology security.
- Assist the system owner in developing security plans, risk assessments, and supporting documentation for the certification and accreditation process.
- Ensure that any changes to RPMS that affect contingency and disaster recovery plans are conveyed to the person responsible for maintaining continuity of operations plans.
- Ensure that adequate physical and administrative safeguards are operational within their areas of responsibility and that access to information and data is restricted to authorized personnel on a need to know basis.
- Verify that users have received appropriate security training before allowing access to RPMS.
- Implement applicable security access procedures and mechanisms, incorporate appropriate levels of system auditing, and review audit logs.
- Document and investigate known or suspected security incidents or violations and report them to the ISSO, CISO, and systems owner.
- Protect the supervisor, superuser or system administrator passwords.
- Avoid instances where the same individual has responsibility for several functions (i.e., transaction entry and transaction approval).
- Watch for unscheduled, unusual, and unauthorized programs.
- Help train system users on the appropriate use and security of the system.
- Establish protective controls to ensure the accountability, integrity, confidentiality, and availability of the system.
- Replace passwords when a compromise is suspected. Delete user accounts as quickly as possible from the time that the user is no longer authorized system. Passwords forgotten by their owner should be replaced, not reissued.
- Terminate user accounts when a user transfers or has been terminated. If the user has authority to grant authorizations to others, review these other authorizations. Retrieve any devices used to gain access to the system or equipment. Cancel logon IDs and passwords, and delete or reassign related active and back up files.
- Use a suspend program to prevent an unauthorized user from logging on with the current user's ID if the system is left on and unattended.

- Verify the identity of the user when resetting passwords. This can be done either in person or having the user answer a question that can be compared to one in the administrator's database.
- Shall follow industry best standards for systems they are assigned to; abide by all Department and Agency policies and procedures.

Privileged Users Shall Not:

- Access any files, records, systems, etc., that are not explicitly needed to perform their duties.
- Grant any user or system administrator access to RPMS unless proper documentation is provided.
- Not release any sensitive agency or patient information.
