I made a presentation to the Midwest Alliance of Sovereign Tribes (M.A.S.T.) on July 10th regarding the qualifications and competencies required of Senior Executive Service (SES) as well as the process of determining qualified applications and selection of a candidate. The SES qualifications may be found on the OPM website at http://www.opm.gov/ses/references/GuidetoSESQuals_2012.pdf. The announcement closes on August 5, 2013 and applications must be submitted through the online process. Applications will be reviewed and a panel of those applicants meeting qualifications will be presented to the IHS Directors office for interview. Area Tribes may choose to have a representative involved in the interview process or have a selected panel of Tribal Leaders involved. Recommendations will be made to the Director following the interviews. The selection is made by the IHS Director. Questions should be directed to michele.bowseraguilar@ihs.gov.

PRE-NEGOTIATION MEETING

The Area held the 2014 Pre-Negotiation meeting with Area Tribes on May 21, 2013 in Acme, MI. Though we could not provide the Headquarters and Area tables nor the Tribes specific detail sheets, there were many items to discuss. For those who were unable to attend, meeting packets were mailed to the Health Director. On July 8th Deanna Dick sent out follow-up items from the meeting. These included: a table of specific follow-up items which have all been completed except the survey will close on July 19th; the Indian Health Care Improvement Fund Concept diagram; the 2000 memo on IHS eligibility for direct service; the October 28, 1999 Federal Register notice on eligibility; List of OEH&E FY13 pool projects; Survey information on funding and distribution of fluoride funds. OEHE has prepared the final report showing the 10 year retrospective on SFC projects and individual reports will be sent to Health Directors. AFFORDABLE CARE ACT (ACA)

We continue to hold ACA trainings throughout the Area. In April we held a 1.5 day session in Walker, MN, in May a 1 day session in Acme, MI, and in June a 1.5 day session in Danbury, WI. I want to thank

our trainers Phil Norrgard and Jennifer DuPuis (Walker and Danbury sessions) and Derek and Tanya Bailey for the training in Acme. I also want to thank the College of St. Scholastica School of Social Work for partnering with us to do group activities, notes and follow-up with participants at the Walker and Danbury sessions. We plan to continue training throughout the rest of the summer and fall. New information is being received as rules and regulations are written or clarified and we have been mailing these out as we receive notices. Training announcements will be sent when scheduled. BEMIDJI AREA INFORMATION TECHNOLOGY CONFERENCE

The annual Area Information Technology Conference was held June 25-27, 2013 in Shakopee, MN. Topics addressed included updates on Vista, EHR, RPMS, Meaningful Use, Health information exchange, Information Security Agreements and an update from the IHS Chief Information Officer. Breakout sessions included using technology to tell stories and diabetes, Behavioral Health, HIPAA, ICD-10 and Release of Information, wide area networks (WAN), e-prescribing, registration/scheduling GUI, risk assessments, system management, and virtual environments. The 2014 meeting is tentatively planned for April or May as we prepare for Hi-Tech and ICD-10.
