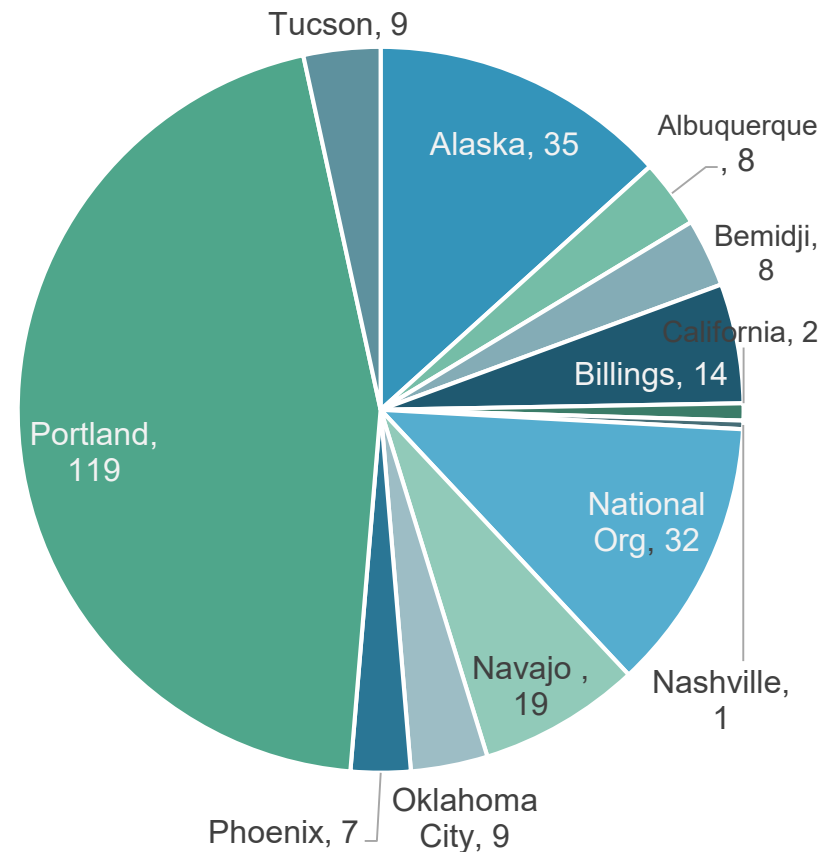


Tribal Consultation Updates

- Consultation initiated a 30-day commented period on May 7, 2019 for comments on the draft National CHAP policy
- Received requests from Tribes to extend the comment period an additional 30 days.
- Comment period closed on July 8, 2019

Tribal Consultation at a Glance

- IHS received input from 37 Tribes, Tribal Organizations, and national organizations
- This yielded 263 individual comments
