## 2. Performance Measures Update (David McMahon)

- a. 2016-2020 Measures
  - i. Environmental Surveillance and Injury Intervention Performance Measures - FY17 reporting interventions
  - ii. See "2017 PM Reporting Interventions" guidance document attached to calendar call invitation and Adobe Connect (PDF file available at https://ihs.adobeconnect.com/p1ind3c0p8v/)
    - ES Performance Measure: SurveyMonkey (<a href="https://www.surveymonkey.com/r/FY17ES">https://www.surveymonkey.com/r/FY17ES</a>) will be the tool used to report and collect your Area's interventions
    - IP Performance Measure: Use your Area's R/C/P 'IP PM16-20' in WebEHRS to report the interventions developed and implemented in FY2017 to increase driver seat belt use (due into WebEHRS by August 31, 2017)
  - iii. Discussion ES Performance Measure: if multiple surveys are conducted at one establishment and no surveys are conducted of other eligible establishments, inaccuracies or true representation of the performance measure may result (i.e. under or over reporting); this is recognized as a limitation of the data reporting and collection tool that HQ will work with CDP to overcome
  - iv. Discussion ES Performance Measure: should the same interventions be implemented throughout an Area, District, or Service Unit; its flexible for each Area to determine; three Areas stated they would select three interventions universally applied across their Area

#### 4. Head Start Environmental Health Survey Reference Issues

- a. Situation: Do we need to establish in policy specifically what references our staff are using for EH surveys?
  - i. How immediate should the issue to be resolved?
  - ii. What are some short-term and long-term solutions to at least get to a place where we are comfortable with the references staff are using for EH surveys?

## b. Background:

- Head Starts concerned that IHS EH staff conduct inspections of their buildings based on 2000 Model Code which does not align with current Head Start Performance Standards
- ii. eSurvey WKGP currently updating childcare center survey checklist based on Caring for Our Children 3<sup>rd</sup> Ed.; this checklist might be similar to a new Head Start checklist based off the 2016 Head Start Performance Standards
- iii. Chapter 11 does state suggested references for various EH issues, but it does not state these are the adopted national reference standards for those EH issues
- iv. There is recognition of standards people should be using, but also some standards that people use which is not the best example

#### c. Assessment:

- i. Some staff are not clear as to what the standard reference documents they should use; in "some of these surveys we're just kind of out there" making recommendations
- ii. An issue with the Head Start Performance Standard is items that Head Start requires be assessed may be beyond the scope of expertise or skill set of EH staff, this leaves some staff to wonder if we're not assessing it as the inspector who is (e.g. should issues around nutrition be assessed by EH)?

- ii. A crosswalk of the Head Start Model Code and the 2016 Head Start Performance Standards would be a nice place to start, and to help make a decision; does Head Start already have one?

    - Whiteriver Service Unit Sr. EH Specialist; Whiteriver, AZ: Mr. Daniel Dicks selected as Sr. Environmental Health Specialist; reports on 12/27; has over 40 years of experience in public health practice, including 20 years with the US Army and 20 years serving various positions in county government and industry
    - 2. Eastern Arizona District IP Coordinator, Lakeside, AZ: Interviews are underway and a selection is anticipated within the next week or so. We hope to have the new hire on board in early January and spend some time with Jon Peabody prior to his pending retirement in the late winter/early spring
    - 3. Service Unit EH Specialist Vacancies; Parker, AZ and San Carlos, AZ: The vacancy announcement (Pathways) for both position closed; HR reports 58 applications were received and are under review; as a result of the number of applications, it is anticipated a certificate will not be issued until January; the Pathways hiring authority continues to serve as an exceptional recruitment tool
    - 4. Commissioned Corps CAD: Of the 10 new hires (Pathways) over the past year, four have converted to CC or have received notice of an OBC date; the time period between 1662 issuance and CAD was 7 to 11 months
