Tularemia Case Investigation: NV tribal reservation resident passed away and was organ donor; trace back investigation of organ recipients positive with tularemia identified donor as source; Phoenix Area DEHS partnered with Tribe, CDC, and state to conduct environmental investigation; rabbit carcasses near deceased member's home found to be positive with same genetic Tularemia markers as that among human cases in the investigation; also held community meeting to discuss Tularemia risks and protective factors; it is likely the case study will be written up in CDC's MMWR since this is the first known cases in which tularemia was contracted through organ donation
 - vii. Opioid Poisonings: Phoenix Area IP team working with state public health program officials and helping connect tribal law enforcement to training and Naloxone; also working with stakeholders (state, IHS, Tribal) in better defining opioid poisoning problem through review of local data systems and improving data collection efforts (including through post mortem blood analysis of suspect cases)
