

#### Summary


- Influenza activity is widespread. This week's report continues to indicate an overall decrease in influenza-like-illness outpatient visits.
- Influenza vaccine coverage is increasing, but many patients remain unvaccinated.

Percentage of ILI visits is number of ILI visits divided by total number of daily visits.








