**TARGET AUDIENCE:** Physicians, Nurses, Registered Dietitians, Health Promoters, Fitness Specialist, Environmental Health Professionals other members of the care team and other interested parties.

**DISCRIPTION:** Second-hand smoke exposure has been shown to be a significant cause of premature morbidity and mortality, and is an important health risk that should be assessed by healthcare providers. While many states and communities have implemented smoke-free policies, those policies do not apply to tribal lands. Our research findings have relevance to clinicians who treat American Indian and Alaska Native populations because it helps to characterize why smoke-free policies have not been implemented in tribal lands.

## **OUTCOMES/OBJECTIVES:**

1. Distinguish the differences between ceremonial tobacco vs commercial tobacco and their relations to smoke-free policies on Tribal lands.
2. List factors that impede and promote the passage of smoke-free policies on Tribal lands.
