



Tribal Injury Prevention Cooperative Agreement Program (TIPCAP)

TIPCAP is part of the Indian Health Service Injury Prevention Program and was formed in 1997 to combat unintentional injuries in Native populations in the United States.

TIPCAP's Mission

The mission of TIPCAP is to raise the health status of American Indians and Alaska Natives (AI/ANs) to the highest possible level, by decreasing the incidence of severe injuries and death to the lowest possible level, and increasing the ability of tribes to address their injury problems.

Why Injury Prevention?

The impact of injuries is greater on AI/AN communities than on other racial and ethnic groups. The unintentional injury death rate for the AI/AN population is nearly 2.5 times that of the US all races unintentional injury death rate.

TIPCAP Funding

TIPCAP is a 5-year cooperative agreement program that awards funding to federally recognized tribes or tribal/urban organizations to implement focused, community-based injury prevention programs and projects using evidence-based strategies.

TIPCAP Grantees

TIPCAP grantees are categorized in two programs:

- **Part I grantees** are funded to implement and develop an injury prevention program and are awarded up to \$125,000/year and includes the hiring of a fulltime Injury Prevention Coordinator.
- **Part II grantees** are funded to develop injury prevention projects that are evidence-based or innovative strategies and are awarded up to \$32,000/year.

Prevention Focus Areas

Based upon community need, TIPCAP grantees can focus on one or more of the following injury types: motor vehicle-related, falls, drowning, fire/burn, poisoning/overdose, suicide, and violence-related injuries.

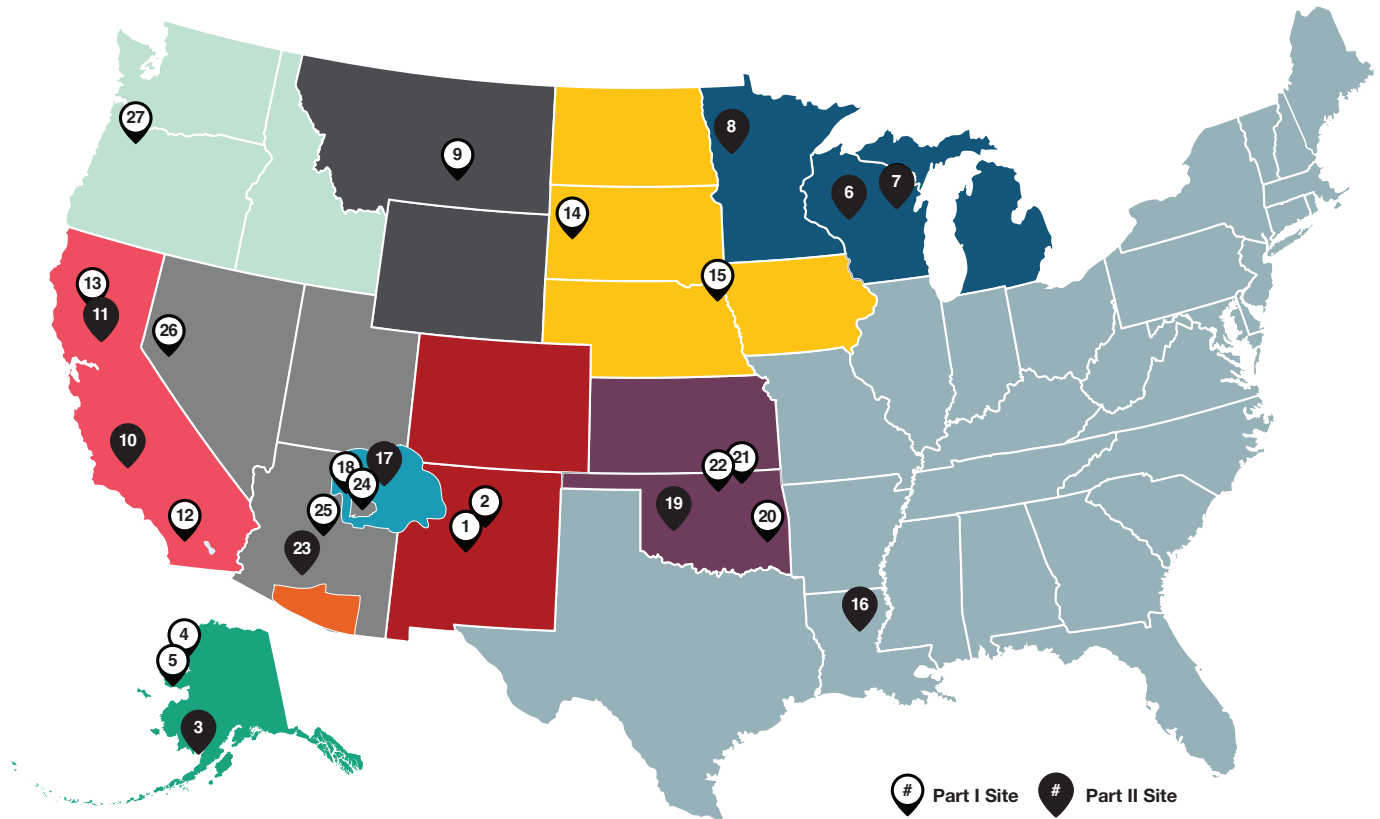
