Dear Urban Indian Organization Leader:

On behalf of the Indian Health Service (IHS), I am initiating Urban Confer to seek your input on two initiatives: (1) the use of \$5 million from the Fiscal Year (FY) 2021 appropriations that the IHS has allocated to address Alzheimer’s disease; and (2) the use of \$5 million in funding for *Ending the Human Immunodeficiency Virus (HIV) Epidemic (EHE): A Plan for America*, which was allocated to support work toward the elimination of HIV and hepatitis C (HCV) in Indian Country.

The IHS Office of Clinical and Preventive Services (OCPS) will host a virtual learning session to provide additional information on both initiatives, including information on the Agency’s requirements for implementation and activities to date for each specialty area.

I invite you to provide feedback and recommendations on the following:

Alzheimer’s Disease Initiative:

- Exploring how the IHS might use available funding to support sustainable, comprehensive models of care for persons living with dementia and their families through IHS, Tribal, and Urban Indian health programs;
- Investing in an effort to improve awareness, early recognition, and diagnosis of Alzheimer’s disease and related dementias, in partnership with Tribal communities;
- Investing in competency-based training for all clinical staff to improve diagnosis, assessment, and management of Alzheimer’s disease and related dementias in IHS, Tribal, and Urban Indian health programs; and
- Investing in evaluation and data to assess the impact of Alzheimer’s disease and related dementias, the needs of those living with dementia and their families, and the effectiveness of efforts to address and improve management of Alzheimer’s disease.

Ending the HIV Epidemic Initiative:

- Exploring how the IHS might use available funding to support IHS, Tribal, and Urban Indian health programs to achieve the Ending the HIV Epidemic goal of a 75 percent reduction in new HIV infections by 2025 and at least a 90 percent reduction by 2030; and
- Key strategies for implementing the Ending the HIV Epidemic include: (1) diagnosing all people with HIV and HCV as early as possible; (2) treating people with HIV and HCV rapidly and effectively to reach sustained viral suppression; (3) preventing new HIV and HCV transmissions by using proven interventions, including pre-exposure prophylaxis and syringe service programs; and (4) responding quickly to potential HIV and HCV outbreaks to get needed prevention and treatment services to people who need them.
