I. Purpose

The purpose of this report is to satisfy the reporting requirements under the Buy Indian Act, 25 U.S.C. § 47, as amended by the Indian Community Economic Enhancement Act of 2020 (Public Law 116–261) to include the new reporting requirements, excerpted below:

SEC. 4. BUY INDIAN ACT

Section 23 of the Act of June 25, 1910 (commonly known as the "Buy Indian Act") (36 Stat. 861, chapter 431; 25 U.S.C. 47), is amended to read as follows:...

- "(d) REPORT.—
- "(1) IN GENERAL.—Not later than 1 year after the date of enactment of this section, and not less frequently than once every 2 years thereafter, each of the Secretaries shall submit to the Committee on Indian Affairs of the Senate and the Committee on Natural Resources of the House of Representatives a report describing, during the period covered by the report, the implementation of this section by each of the respective Secretaries.
- "(2) CONTENTS.—Each report under this subsection shall include, for each fiscal year during the period covered by the report—
- "(A) the names of each agency under the respective jurisdiction of each of the Secretaries to which this section has been applied, and efforts made by additional agencies within the Secretaries' respective Departments to use the procurement procedures under this Act;
- "(B) a summary of the types of purchases made from, and contracts (including any relevant modifications, extensions, or renewals) awarded to, Indian economic enterprises, expressed by agency region;
- "(C) a description of the percentage increase or decrease in total dollar value and number of purchases and awards made within each agency region, as compared to the totals of the region for the preceding fiscal year;
- "(D) a description of the methods used by applicable contracting officers and employees to conduct market searches to identify qualified Indian economic enterprises;
- "(E) a summary of all deviations granted under section 1480.403 of title 48, Code of Federal Regulations (or successor regulations), including a description of—
- "(i) the types of alternative procurement methods used, including any Indian owned businesses reported under other procurement goals; and
- "(ii) the dollar value of any awards made pursuant to those deviations;
- "(F) a summary of all determinations made to provide awards to Indian economic enterprises, including a description of the dollar value of the awards;
- "(G) a description or summary of the total number and value of all purchases of, and contracts awarded for, supplies, services, and construction (including the percentage increase or decrease, as compared to the preceding fiscal year) from—
- "(i) Indian economic enterprises; and "(ii) non-Indian economic enterprises;
- "(H) any administrative, procedural, legal, or other barriers to achieving the purposes of this section, together with recommendations for legislative or administrative actions to address those barriers; and
- "(I) for each agency region—

- "(i) the total amount spent on purchases made from, and contracts awarded to, Indian economic enterprises; and
- "(ii) a comparison of the amount described in clause (i) to the total amount that the agency region would likely have spent on the same purchases made from a non-Indian economic enterprise or contracts awarded to a non-Indian economic enterprise.

In addition to meeting the reporting requirements of the Buy Indian Act, the information in this report is used by the Indian Health Service (IHS) to document the implementation of the Buy Indian Act and report compliance with requirements under the law. The United States (U.S.) Department of Health and Human Services (HHS) and the U.S. Department of Interior (DOI) use the information contained in this report to demonstrate the implementation of this law through small business economic development programs that support Tribal economic development.

II. Background

In December 2020, the President signed the Indian Community Economic Enhancement (ICEE) Act, which included the requirement for HHS and DOI to collaborate on implementing consistent procurement procedures in support of the Buy Indian Act. On March 14, 2022, the HHS Final Rule in support of the Buy Indian Act was made effective, which further updated the HHS Acquisition Regulations (HHSAR). Within HHS, the Buy Indian Act is specifically applicable to the IHS and acquisitions conducted on behalf of the IHS. This is the first IHS Report to the Congress of the United States on the Buy Indian Act Implementation, prepared for fiscal years 2022 and 2023.

The IHS Buy Indian Act final rule formalizes the administrative and acquisition procedures for all IHS acquisition activities and locations. This includes all IHS Areas, IHS Service Units, and all IHS Headquarters offices. In November 2022, the IHS negotiated with the HHS Office of Small and Disadvantaged Business Utilization (OSDBU) to identify an IHS fiscal year (FY) 2023 Buy Indian Act goal of 20 percent of total eligible small business dollars - which meant the IHS would target acquisitions toward Native American businesses for at least 20 percent of all IHS acquisitions. This was the agency's first established Buy Indian Act goal, which was announced during the 2022 White House Tribal Nations Summit.

The Agency's goal and the data provided in this report includes contracts awarded to Native American-owned (also termed Native-owned) businesses that were not limited to competition under the Buy Indian Act. Native American-owned entities could qualify as Indian Economic Enterprises (IEEs); however, these entities may not all have been Buy Indian Act certified. This may have impacted some of the reporting data in some of the charts, as noted in each chart.

III. Agency Accomplishments

• The IHS reported that the agency exceeded its 20 percent Buy Indian goal by obligating \$444M or 30.6 percent in eligible contract dollars to Native-owned and controlled businesses.

- The IHS reported exceeding all IHS Small Business socio-economic goals set by the HHS Office of Small Disadvantaged Business Utilization (OSDBU).
- In April 2023, HHS and the IHS partnered with DOI, BIA, and the APEX Accelerators (formerly known as the Procurement Technical Assistance Centers- PTACs) to host the inaugural Buy Indian Small Business Industry Day in Rockville, MD. The live event was attended by more than 150 non-federal attendees, and exceeded 650 participants in the virtual matchmaking event. This event promoted collaboration and networking, allowed federal staff a chance to conduct market research, as well as allowed HHS and DOI leadership a chance to inform the business community about HHS and DOI progress implementing the Buy Indian Act.
- The IHS required specific performance language in all Senior Executive Service FY 2023 performance plans including the requirement to demonstrate leadership, partnering, and progress toward achieving the IHS Buy Indian Act procurement goal.
- The IHS Area Offices participated in small business, health, and economic conferences in their respective areas including the American Indian Chamber of Commerce of Oklahoma Economic Conference in Tulsa OK (July 2023); the Native American Development Corporation (NADC) Annual Economic Development Summit in Billings, MT; and the Annual Tunica-Biloxi Procurement Conference in Marksville, LA (August 2023). In addition, the Albuquerque Area IHS conducted its first and only (to date) Small Business Indian Firm Industry Day and Virtual Matchmaking session in August 2023.
- The IHS collaborated with the General Services Administration (GSA) to identify, enable, and expand the search tool on GSA Advantage and GSA E-library to recognize Native-owned GSA contract holders. This feature allows for IHS program and contract staff to successfully identify and locate Native American-owned and controlled businesses that hold GSA contracts.
- The IHS updated the Indian Health Manual (IHM) 5-5.6 "Buy Indian Act Compliance and Contract File Review" located at https://www.ihs.gov/ihm/pc/part-5/p5c5/#6-1, to support the agency's reporting of Buy Indian Act deviations and challenges. The IHS manually collects deviations and challenges data each quarter from Area Chief Contracting Officers (CCO). The data is uploaded to an established IHS network folder managed by the IHS Headquarters (HQ) Division of Acquisition Policy (DAP). The IHS is developing a Buy Indian Act reporting tool and dashboard that will launch in 2024. This new tool and dashboard will allow for IHS Areas, Service Units, and HQ to upload and generate Buy Indian Act reporting documents.

IV. IHS Spending Summary

Below is a summary of the spending data by IHS Area Offices, including IHS Headquarters, and the Division of Engineering Services. These are the IHS estimates of eligible contracts under the Buy Indian Act; however, some of these awards were awarded using competitive procedures or

other small business programs that were not limited to completion under the Buy Indian Act.

- During FY 2022, the IHS Contracting offices obligated \$324,035,790 to Native-owned businesses (defined on page 4), which is 20.9 percent of total eligible dollars under the Buy Indian Act.
- During FY 2023, the IHS contracting offices obligated \$443,966,073 to Native-owned business (defined on page 4), which is 30.6 percent of total eligible dollars that were awarded to Native-owned companies.




Figure 1: Albuquerque Area Top 5 NAICS FY2022




Figure 2: Albuquerque Area Top 5 NAICS FY2023




Figure 3: Bemidji Area Top 5 NAICS FY2022




Figure 4: Bemidji Area Top 5 NAICS FY2023




Figure 5: Billings Area Top 5 NAICS FY 2022




Figure 6: Billings Area Top 5 NAICS FY 2023




Figure 7: California Area Top 5 NAICS FY 2022




Figure 9: Headquarters Top 5 NAICS FY 2022




Figure 10: Headquarters Top 5 NAICS FY 2023




Figure 11: DES Top 5 NAICS FY 2022




Figure 12: DES Top 5 NAICS FY 2023




Figure 113: Great Plains Area Top 5 NAICS FY 2022




Figure 124: Great Plains Area Top 5 NAICS FY 2023




Figure 15: Nashville Area Top 5 NAICS FY 2022




Figure 16: Nashville Area Top 5 NAICS FY 2023




Figure 17: Navajo Area Top 5 NAICS FY 2022




Figure 13: Navajo Area Top 5 NAICS FY 2023




Figure 149: Oklahoma City Area Top 5 NAICS FY 2022




Figure 20: Oklahoma City Area Top 5 NAICS FY 2023




Figure 21: Phoenix Area Top 5 NAICS FY 2022




Figure 22: Phoenix Area Top 5 NAICS FY 2023




Figure 23: Portland Area Top 5 NAICS FY 2022




Figure 24: Portland Area Top 5 NAICS FY 2023

Methods Used

(D) IHS contracting offices issued Sources Sought Notices and Requests for Information to identify Indian Economic Enterprises. These notices and requests where posted on www.sam.gov and were available for any Enterprise to respond. IHS Contracting Officer's Representatives, Program/Project Managers, and other requiring office program offices conducted market research. Marketing research methods included using a variety of sources including outreach at virtual and in-person industry events, matchmaking sessions, website searches, and searches of publicly available databases including, but not limited to: HHS Small Business Customer Experience; DOI Native American Businesses in SAM.gov Dashboard tool; FPDS-NG; and GSA resources. In FY 2023, the IHS established a dedicated Buy Indian agency email, IHSBuyIndian@ihs.gov, that is monitored by staff at IHS Headquarters, DAP. Companies can submit information including capability statements to this shared email and information is disseminated on a central web-based document sharing platform.

Buy Indian Act Deviations

- (E) A summary of all Buy Indian Act deviations granted under section 1480.403 of title 48, Code of Federal Regulations (or successor regulations), including a description of—
 - (i) the types of alternative procurement methods used, including any Indian-owned businesses reported under other procurement goals; and
 - (ii) the dollar value of any awards made pursuant to those Buy Indian Act deviations.

Below is a summary of all Buy Indian Act deviations granted under HHS Acquisition Regulations 326.603:

- IHS approved 702 Buy Indian Deviations in FY 2023.
- The estimated total contract value range was most commonly between \$25k and \$700k. This range required the signatures of the Contract Specialist, Contracting Officer and Chief Contracting Officer for the area (or the IHS Division of Acquisition Policy Director, absent a Chief Contracting Officer).
- The types of alternative procurement methods used included use of other socio-economic goals such as Small business, 8(a) and HUBZone.
- Regarding the reporting requirement under Section E (ii), for FY 2022 and FY 2023, the IHS is not able to readily calculate the dollar value of the awards made under these approved Buy Indian Act deviations. The IHS will start tracking this data in FY 2024.

Summary of Determinations

- (F) A summary of all determinations made to provide awards to Indian economic enterprises, including a description of the dollar value of the awards.
 - A summary of the determination to provide an award to an IEE would be filed in each respective contracting file based on the responses to RFIs and Sources Sought Notices. In FY 2022 and FY 2023, the IHS did not have a central repository to collect this information centrally for reporting purposes, and therefore a summary is not available for FY 2022 and FY 2023. However, the IHS will start tracking this information in FY 2024.
 - (G) A description or summary of the total number and value of all purchases of, and contracts awarded for, supplies, services, and construction (including the percentage increase or decrease, as compared to the preceding fiscal year) from Indian economic enterprises and non-Indian economic enterprises.
 - A summary of the awards to Native-owned businesses is included in Tables 31 and 32, with a breakdown by Area/HQ Office of both dollars awarded and increases/decreases. As shown by the data in Tables 29 and 30, there was a decrease in contracting overall, including to businesses that are not Native-owned, between FY 2022 and FY 2023. For the same time period, there was an increase in awards to Native-owned businesses.
 - (H) Any administrative, procedural, legal, or other barriers to achieving the purposes of this

section, together with recommendations for legislative or administrative actions to address those barriers.

- The Fiscal Responsibility Act of 2023 requires that all federal agencies act to reduce contract costs in FY 2024 and FY 2025. In response, all HHS Operating and Staff Divisions will ensure the application of category management practices to bring centralized spending into alignment. There are very few Native-owned businesses holding contracts under Veterans Administration (VA), General Services Administration (GSA), NIH, and NASA or other Government Wide Acquisition Contracts (GWACs) and Multiple Award Schedule (MAS) Indefinite Delivery Indefinite Quantity (IDIQs).
- A few of the required Buy Indian Act reporting requirements are administratively burdensome to collect including items F; G; and I (ii). IHS is working to establish possible opportunities for collecting this data on a recurring basis.

(I) For each agency region—

- (i) the total amount spent on purchases made from, and contracts awarded to, Indian economic enterprises (Table 34); and
- (ii) a comparison of the amount described in clause (i) to the total amount that the agency region would likely have spent on the same purchases made from a non-Indian economic enterprise or contracts awarded to a non-Indian economic enterprise.
 - The IHS was not able to project this for this reporting period but plans to address this in follow-up reports.
