For sites sending GPRA data utilizing the HL7 or ASD file formats, this document provides instruction on those data fields and the required format.

## Immunization Contra-Indications

**Reason for Contra-indication** (HL7 – ZRC Segment Field 3; ASD – ASDP200 Position 9). The following table lists examples of expected values (those highlighted are specifically searched for in current reports). Please note, the match must be exact, including upper/lowercase characters:

**Women’s Health (WH) Results** (HL7 – OBX WH Segment Field 5; ASD – ASDP400 Position 9).

The contents of this field are currently looked at only if the women’s health procedure is one of the following:

- MAMMOGRAM SCREENING
- HPV SCREEN
- PAP SMEAR

In these 3 cases, the result field is checked for the value ‘ERROR/DISREGARD.’ Please note, the match must be exact, including upper/lowercase characters.
